**MAP 722/08 (AMENDMENT): 70 WEST COMMERCE PARK (ROAD ONLY);** an amendment to a previously approved major plat, 1,008 acres, Liberty Township, S25-14-1E, located for Phase I west of State Road 39, east of County Road 100 East, north of County Road 1000 South and for Phase 2 east of County Road "0," west of County Road 100 East and south of County Road 1000 South. (Beam, Longest & Neff)

**ZA 394/09: NEW WINCHESTER PROPERTIES, LLC;** a zoning amendment change from NB/Neighborhood Business District to LI/Light Industrial District, 4.88 acres, Marion Township, S4-T15N-R2W, located at the northeast corner of U.S. Highway 36 West and State Road 75. **ZA 395/09: WEST CENTRAL INDIANA PLUMBING, INC.;** a zoning amendment change from AGR/Agriculture Residential District to GB/General Business District, 1.55 acres, Center Township, S30-T16N-R1W, located on the north side of State Road 236, approximately 0.50 mile west of County Road 200 West. (Comer Law Office)

**MAP 716/09 (AMENDMENT): THE RESERVE AT FOREST COMMONS, SECTION 1;** an amendment to an approved 1-lot major subdivision, 9.5 acres, Washington Township, S35-T16N-R1E, located west of Forest Commons, Section 1 and south of Forest Commons, Section 3. (Kruse Consulting, Inc./Wonderwall Land Development Services)
