

Correctional Services, Inc. is a company which designs cost-effective and efficient solutions for the Criminal Justice System. We specialize in the development, implementation, and operation of privatized sentencing alternatives for misdemeanants and first-time D-Felony offenders.

One such sentencing alternative is the use of cognitive-based education and training designed to change attitudes and behaviors. The concept is to focus on the thought process related to criminal activity and to try to change that process. Accepting responsibility for actions without blaming others is an essential component of the classes. A standardized and validated curriculum is used, which includes a workbook for the group participants. Instructors have been certified by a national organization in the use of curriculum and group facilitation.

The facilitator is R. Todd McCormack, who has over twenty-three years of Criminal Justice experience, with eighteen of those years in the capacity of a Chief Probation Officer.

Mr. McCormack has been a faculty member of the Indiana Judicial Center for the past seventeen years. He has a Master's Degree in Criminal Justice and Corrections, and he completed his training to be certified as a facilitator in 1999.

Classes will be held in the Plainfield Town Courtroom, located at 1075 W. Main Street, Plainfield, Indiana. The building is located at the intersection of US Highway 40 and Moon Road (County Road 600 E.). All classes will begin at 8:00am and end at approximately 4:00pm. You will only be required to attend one class. There is only one class offered per month.

An hour for lunch on your own will be allowed, and there will be breaks throughout the class. **There will be no smoking in the classroom.**

The class is designed and appropriate for a variety of topics, including:

**Anger Control
Theft (Bad Check / Shoplifting)
Controlled Substance (Marijuana)
Minor in Possession
Parenting**

These classes will focus on: responsibility, trust, dealing with stress, being in control, the effects of alcohol and drugs on behavior, wants vs. needs, budgeting, and understanding the effects of the crime on the victim and society.

The cost of the class is \$75.00, paid in advance, and includes a workbook and other necessary materials.
