Member Bob Gentry moved to follow the Surveyor's recommendation. Member Stan Ryland seconded the motion. The motion was unanimously passed.

RE: HENDRICKS COUNTY SURVEYOR DAVID GASTON:

Ronald Reagan Parkway

Hendricks County Surveyor David Gaston presented the Board with Doctor Gary Maloney's drainage layout for his property in relevance to the Ronald Reagan Parkway drainage plans. Discussion followed. President Whetstone asked Mr. Gaston to forward the layout to Hendricks County Engineer John Ayers. Mr. Gaston said he would send it after the meeting.

Roseboom Regulated Drain

Mr. Gaston informed the Board that there had been an error with the Roseboom Regulated Drain watershed assessment. Mr. Gaston stated in 2017 the Board voted to combine all the assessments of the Roseboom watershed drains together into one drain account as we did with the Ross Regulated Drain. He stated after that meeting, the Board Secretary sent up an email and the Drainage Board minutes requesting the combination. Unfortunately, instead of combining the watershed drains assessments into one account, the Auditor's Office turned off the assessments for this year. Member Stan Ryland asked how much of a loss occurred. The secretary said approximately \$185,000.00. Mr. Gaston stated the Auditor's Office was working on fixing the problem. Discussion followed. The Board thanked Mr. Gaston for bringing the matter to their attention.

Cambridge Regulated Drain

Mr. Gaston asked Hendricks County Chief Deputy Cory Gehring to fill the Board in on the situation near the Cambridge Regulated Drain. Mr. Gehring reminded the Board that they had asked the Surveyor's Office to use some of the spoils of rock left over from the Cambridge Regulated Drain outlet project to shore up the erosion happening on the Steel's property. Unfortunately, while Mink Excavating was working on spreading the rock, the temperature rose enough to make the ground soft and their equipment rutted the ground. Mrs. Steele called in to say they were not happy with the mess the contractor had left. Mr. Gehring explained to her that the contractor was not finished with the project and would return to fix the situation. Discussion followed. The Board asked to be kept updated on the project.

Barnett Regulated Drain

Mr. Gaston stated his office had received two sealed quotes for dipping of the Barnett Regulated Drain and one sealed quote for the two culverts needing to be replaced. Mr. Gaston said all parcel owners had agreed to allow the project to proceed during growing season. Discussion followed. The sealed quotes were opened and were as follows:

Dipping 13,900 feet of the drain

Murrain Excavating \$34,700.00 Arthur's Excavating \$25,325.00

Replacing 2 culverts

Murrain Excavating \$ 25,500.00

Mr. Gaston recommended Arthur's Excavating for the dipping project (\$25,325.00) and Murrain Excavating for the culvert project (\$25,500.00) as the lowest competent quotes. Member Bob Gentry

moved to follow the Surveyor's recommendation. Member Jack Maloney seconded the motion. The motion was unanimously passed.

Stratford of Avon Regulated Drain

Mr. Gaston said JR Bowling had finished on the Stratford of Avon Regulated Drain Phase Two project, however, the Bryant's were not pleased with the way they had patched their driveway. Mr. Gehring stated they were supposed to repave a larger portion of the driveway, but only patched the portion where the pipes went through. Mr. Gaston stated they would not be paid until the driveway was repaved completely per the Scope of Work for the project. Discussion followed.

RE: IN THE MATTER OF WISHES TO BE HEARD:

Mike Starkey

President Whetstone recognized Mike Starkey. Mr. Starkey said while the crews were out doing locates on the tiles on his property for the Ronald Reagan Parkway project, they did some damage to the field and outlet causing some erosion. Mr. Gaston said they would have someone go out and inspect the area and fix any damage. Discussion followed. Mr. Starkey also asked if there would be any compensation for having to go out and remove all the stakes the crew placed. He was told the crew would remove them, but when he went to plant his crops they were still there. President Whetstone stated he would need to take that up with the Commissioners. Mr. Starkey said during his survey of the area he had located Gary Maloney's tiles and one of his main trunk lines runs directly in line with where one of the new ponds it supposed to go. President Whetstone stated that he would need to take that up with the Commissioners as well. Mr. Starkey said one of the barrow pits that will become a pond for the project does not have a proper fence around it and he is concerned someone might fall in. Mr. Gaston stated before the project is finished the pond basin and surround will be brought into line with the County Ordinance and have a safety ledge and fence. In the meantime, he would speak to John Ayers about putting up a better temporary fence. President Whetstone asked Mr. Starkey to bring this up at the Commissioners meeting.

<u>RE: INTRODUCTION OF OTHER BUSINESS OR ADDITIONAL DISCUSSION BY</u> <u>COMMISSION MEMBERS:</u>

Jack Maloney

President Whetstone recognized Member Jack Maloney. Mr. Maloney presented the Board with a drainage layout for his property in the Ronald Reagan area showing 90,000 feet of pipe. He said the current layout for the Ronald Reagan Parkway project will break through the watershed he has created and wanted to know if the County would reimburse him for the cost to fix it after the Parkway went through. President Whetstone stated he would need to bring that up to the Commissioners. Discussion followed.

ADJOURN:

Seeing nothing further before the Board, Vice President Palmer moved to adjourn the meeting. Members Bob Gentry and Stan Ryland seconded the motion. The motion was passed unanimously.
