RE: HENDRICKS COUNTY SURVEYOR DAVID GASTON:

Deer Meadows Subdivision

Hendricks County Surveyor David Gaston stated that Member Bob Gentry and Pittsboro Town Manager Jason Love had approached Inspector Tiffany Dalton about a 6" regulated drain tile in Deer Meadows Subdivision that was in need of some repair and or replacement. Mr. Love had stated the Town of Pittsboro would pay for all labor and equipment costs if the Drainage Board would pay for all materials. Discussion followed. Member Bob Gentry moved to pay for all material costs for replacing the above referenced drain as long as the Town of Pittsboro pays for all labor and equipment costs. Member Jack Maloney seconded the motion. The motion passed on a 3-1 vote with Vice President Palmer voting against. Vice President Palmer requested it be noted that the Surveyor was not asked, nor did he give a recommendation, and that no cost estimate was obtained for the project.

Timothy Quinn Regulated Drain

Mr. Gaston stated Inspector Dalton had been informed that INDOT had come up with two proposals for the I-74 Timothy Quinn project that he would be reviewing. However, INDOT would have the final say which plan would be implemented. Discussion followed.

Hendricks County Drainage Inspector Dirk Leonard

Mr. Gaston introduced new Hendricks County Drainage Inspector Dirk Leonard to the Board. The Board warmly welcomed Mr. Leonard aboard.
