Surveyor's recommendation. Member Jack Maloney seconded the motion. The motion was unanimously passed.

MRP 102/18 (Phillips) - County

1 lot on 11.988 acres in Liberty Township, S29-T15N-R1E, located at the southwest corner of County Road 350 South and Martin Road. (Kruse Consulting) – *No Regulated Drain.*

Hendricks County Surveyor David Gaston recommended the Hendricks County Drainage Board grant Preliminary & Final Approval of *MRP 102/18 (Phillips)* subject to the conditions of the Hendricks County Surveyor's letter and all the requirements and conditions of the Hendricks County Stormwater Management Handbook. Member Bob Gentry moved to follow the Surveyor's recommendation. Member Stan Ryland seconded the motion. The motion was unanimously passed.

2019 Drainage Board Schedule

Mr. Gaston presented the Board with the 2019 Drainage Board Schedule. Discussion followed. The Board requested the December the 31st meeting be removed from the schedule. Vice President Palmer moved to approve the 2019 Drainage Board Schedule as amended. Member Bob Gentry seconded the motion. The motion was unanimously passed.

Woodcreek Crossing & Woodcreek Farms – Garvey Neal Pollard Todd

Mr. Gaston asked the Board to make the Woodcreek Crossing Subdivision and the Woodcreek Farms Subdivision Regulated Drains arms of the Garvey Neal Pollard Todd Regulated Drain. He stated the GNPT runs directly through both subdivisions and this would simplify the accounting and filing of these drains. Discussion followed. Member Stan Ryland moved to follow the Surveyor's recommendation. Vice President Palmer seconded the motion. The motion was unanimously passed.

Creekwood North Regulated Drain

Mr. Gaston stated his office had only received one quote for the Creekwood North Regulated Drain project. That quote was for \$15,953.00 from Beechwood Construction and after review, he recommended approving it. Discussion followed. Member Jack Maloney moved to follow the Surveyor's recommendation. Member Bob Gentry seconded the motion. The motion was unanimously passed.

Quinn Regulated Drain

Mr. Gaston presented the Board with INDOT's estimate for the boring of the Quinn Regulated Drain project under Interstate 74. He said the estimate was for \$300,000.00 and he believed it to be to low for the project. He informed the Board that he had requested Joe Miller of Banning Engineering review the estimate and discuss the project with INDOT to make sure all the requirements of the project were being met. Discussion followed. The Board pointed out there were several other discrepancies in the estimate and to send it back INDOT for corrections.

December 26th, Drainage Board Meeting

Mr. Gaston stated the Board had mentioned wanting to cancel the meeting on December 26th. Discussion followed. Vice President Palmer moved to cancel and publish the cancellation of the December 26th, meeting of the Drainage Board. Member Jack Maloney seconded the motion. The motion was unanimously passed.

Rudgate Regulated Drain

Mr. Gaston stated he had spoken with Hendricks County Engineer John Ayers about the Rudgate Regulated Drain culvert and he was present to give an update. Mr. Ayers stated they had the elevations they needed for the culvert and would be working out the details for replacing the culvert then get back to the Board with an update.

Barnett & Carver Regulated Drain

Mr. Gaston stated at the last meeting the Board took in a petition to lengthen the Carver Regulated Drain and connect it to the Barnett Regulated Drain. The Board had asked him to investigate the petition and at this time he did not recommend taking in the section requested. He stated he did not believe the benefits to the watershed parcel owners would outweigh the overall cost of the reconstruction of the drain. He believed the parcel owners could dredge out the drain on their own at a much cheaper rate. If they ran into any problems, they could request a removal of obstruction petition to handle them. Discussion followed. Member Jack Maloney moved to follow the Surveyor's recommendation and deny the petition. President Whetstone seconded the motion. The motion was passed on a 4-1 vote with Member Bob Gentry voting against.

RE: IN THE MATTER OF WISHES TO BE HEARD:

Earl Arnold Arm 3 Regulated Drain

President Whetstone recognized Mitchell Alexander. Mr. Alexander requested that Board reduce the easement on the Earl Arnold Arm 3 Regulated Drain from 75 feet to 30 feet, so he may build a home on the property he just purchased. He would also like the Board to clean out or replace the drain and make it functional again. Discussion followed. President Whetstone asked for Mr. Gaston's recommendation. Mr. Gaston stated that he did not recommend reducing the easement. He stated if work needed to be done on the drain, it could be done without damaging all the trees within the entire 150-foot regulated drainage easement that Mr. Mitchell was concerned about. He said that he and Mr. Gentry had spoken and believed at this time the best choice was to expose the tile and try and video it. Discussion followed. Member Bob Gentry moved to follow the Surveyor's recommendation. Member Jack Maloney seconded the motion. The motion was unanimously passed.

<u>RE: INTRODUCTION OF OTHER BUSINESS OR ADDITIONAL DISCUSSION BY</u> <u>COMMISSION MEMBERS:</u>

Ross Regulated Drain

Member Bob Gentry stated Boone County Surveyor Kenny Hedge asked if the Board would start cleaning out the Ross Regulated Drain from State Road 239 up to the Boone County line. Discussion followed. Mr. Gaston stated that since the Board had re-assessed the Ross Watershed, there is money coming in from assessments and the Board did tell parcel owners they would do work on the drain as money became available. Discussion followed. It was the consensus of the Board to start cleaning the Ross from the southern end as money becomes available.

Carolina Commons Regulated Drain

Member Jack Maloney stated there was a fence being built in the drainage easement north of U.S. Highway 36 and on the west side of County Road 900 East in Carolina Commons. Mr. Gaston said he would have one of the inspectors investigate it.

ADJOURN:

Seeing nothing further before the Board, Member Bob Gentry moved to adjourn the meeting. Vice President Phyllis Palmer seconded the motion. The motion was passed unanimously.
