Vice President Whetstone moved to follow the Surveyor's recommendation. Member Bob Gentry seconded the motion. The motion was unanimously passed.

RE: HENDRICKS COUNTY SURVEYOR DAVID GASTON:

County Roads 900 North and 150 East

Hendricks County Surveyor David Gaston informed the Board that Member Bob Gentry had brought a drainage issue that is located near County Roads 900 North and 150 East to his attention. Member Bob Gentry stated there are several issues in the area. First, the roadside ditch needs to be regraded and dipped and the Highway Department has agreed to investigate it. Second, the property owners need to get together and tile their yards, put in perimeter drains around their septic systems, then outlet them into the Nathan Lowe Regulated Drain. Board member Gentry asked Mr. Doug Feltner if he would like to address the Board. President Palmer recognized Mr. Feltner. Mr. Feltner presented the Board with pictures of the areas around his house showing the property before a new house and barn were built and after they were built. The pictures also showed what the area looked like after a heavy rain once the new house and barn were built. Mr. Felton stated that drainage seemed to be stalled and water was standing. Mr. Feltner then asked the Board if it would be the responsibility of the homeowners to pay for this new tiling. The Board indicated it would, but the cost would be much cheaper than if the County would add a new arm to the Lowe Regulated Drain and then the cost passed on to the homeowners. Mr. Gentry indicated the need for a new policy to address new homes and barns being placed without a drainage study or review from the offices of the Surveyor and Planning and Building. Mr. Gaston and Mr. Dombrosky stated that new homes were reviewed but agricultural buildings were not. President Palmer asked Mr. Gaston, Mr. Dombrosky, and Mr. Gentry to meet and review the situation and come back the Board with a recommendation about a policy.

Ross Regulated Drain

Mr. Gaston informed the Board that the Boone County Surveyor, Kenny Hedge, has had multiple complaints from farmers in Boone County about the drainage of the Ross Regulated Drain in Hendricks County. Mr. Gaston informed the Board that a survey of the driveway, road, and railroad crossings across the Ross Regulated Drain needed to be performed to try and discover any blockages that might be occurring along the ditch. Mr. Gaston requested a scope of work from Banning Engineering for this project.

Mr. Joe Miller of Banning Engineering presented the Board with a rough draft of the scope of work. He stated he would work up an estimate based on this report and bring it back to the Board. President Palmer recognized Boone County Surveyor Kenny Hedge. Mr. Hedge said he would like to support any effort to clean up the Ross Regulated Drain as Boone County had recently cleaned up their side of the drain and it was currently holding back water on the Hendricks side. Discussion followed. Vice President Whetstone moved to allow President Palmer to decide if the estimate for the scope of work to be done by Banning Engineering was reasonable and if so, move forward with the project. Member Bob Gentry seconded the motion. The motion was unanimously approved.

William Batz Regulated Drain Reconstruction

Mr. Joe Miller of Banning Engineering stated he had reviewed the bids for the William Batz Regulated Drain Reconstruction and found that at \$124,480.00, Arthur Excavating was the lowest responsible bid. Discussion followed. Member Jack Maloney moved to follow the recommendation. Member Bob Gentry seconded the motion. The motion was unanimously approved.

Joseph Holloway Regulated Drain

Member Jack Maloney said he and Mr. Gentry had driven by the Joseph Holloway Regulated Drain and found that the ponds on the Greystone Estates property were nearly overflowing again. He asked the Board if they would request Murrain Excavating to begin the reconstruction work as soon as possible, even if the conditions were not ideal. Mr. Gaston said he would speak with Tony Murrain and see if they could make some headway on the project.
