Member Stan Ryland moved to follow the Surveyor's recommendation. Member Bob Gentry seconded the motion. The motion was unanimously passed.

Fall Certifications, Splits and Transfers

The Board was presented with the Fall 2019 list of Certifications for Regulated Drain Assessments on approved projects, parcel splits and parcel transfers. Discussion followed. Vice President Whetstone moved to approve the Certifications. Member Bob Gentry seconded the motion. The motion was passed unanimously.

Stratford of Avon

Hendricks County Surveyor David Gaston informed the Board that Growing Image had sent in another estimate for work in the Stratford of Avon Temporary Easement. Discussion followed. The consensus of the Board was to table the estimate until a representative of Growing Image could be present to answer questions.

Leica Equipment – Trade-in and Purchase

Mr. Gaston presented the Board with a list of outdated equipment he planned to trade in to purchase a new Total Station from Leica. He stated the Total Station would be essential in some of the projects the Surveyor's Office would be working on in the near future. Discussion followed. Member Bob Gentry moved to accept the trade in and approve the purchase of the new equipment. Member Stan Ryland seconded the motion. The motion was passed unanimously.

Hendricks County Treasurer – Shawn M. Shelly

President Palmer informed the Board that Hendricks County Treasurer Shawn M. Shelly had withdrawn her request to address the Board. Vice President Whetstone inquired into her request. Mr. Gaston stated that she wanted to talk about the interest accruing on all unpaid balances for the Mary A. Gibbs reconstruction. There are still a few parcels that have not paid their respective reconstruction assessments and the Indiana Code requires a 10% penalty on all unpaid balances each year. Discussion followed. It was the Consensus of the Board to have Hendricks County Attorney Greg Steuerwald speak with the Treasurer Shelly and see what could be done.

Westridge Estates Regulated Drain

Mr. Gaston recused himself from the room before the Westridge Estates Regulated Drain discussion took place due to his friendship with Mr. Ed Kottkamp. Members Stan Ryland and Jack Maloney had reviewed the site and indicated it was a challenging situation. The Regulated Drain was contributing quite a bit of water onto Mr. Kottkamp's property and there did not seem to be a ready or easy solution. Discussion followed. It was the consensus of the Board to have Joe Miller of Banning Engineering review the area and design a solution for the excess water and erosion issues the Regulated Drain was causing on Mr. Kottkamp's property.

Project Continuations – Time Limits

Mr. Gaston stated he would like to put in place a similar time limit on Continuations of projects as the Planning Commission had. He said they allow three (3) continuances after that the project is cancelled/denied, and all fees are forfeited. The project then must wait one year before it can be brought back to the Board. Discussion followed. It was the consensus of the Board to have Mr. Gaston write the new policy and bring it back to the Board for consideration.

President Palmer recognized Mr. Bruce Williams. Mr. Williams said he was concerned with the new subdivision being proposed for the property surrounding his property at 9455 East County Road 100 North, Avon, Indiana. His main concern was with the drainage and the possibility that it could cause a bath tub affect on his property. Discussion followed. Mr. Gaston said the project would have to be brought before the Drainage Board for approval and he would review it to make sure the drainage was up to the County standards.
