IN THE MATTER OF THE AUGUST 1, 2023 REGULAR COUNCIL MEETING MINUTES

IN THE MATTER OF THE HIGHWAY GARAGE PROPOSED PROJECT

County Engineer John Ayers, County Facilities Director Kevin Cavenaugh, and Highway Superintendent Curt Higginbotham were present to discuss the proposed highway garage. Mr. Ayers stated they were charged by the Capital Projects Review Committee to obtain a third party review of the pricing to confirm the architect's estimate was reliable. Mr. Cavanaugh presented the DLZ, LLC Estimate of Probable Construction Cost for the Hendricks County Highway Garage (Phase 1) and the Rigdon Construction Budget Check of the Estimate of Probable Construction Cost for the Hendricks County Highway Garage (Phase 1). Mr. Ayers and Mr. Cavanaugh stated that the overall budget estimate presented by DLZ were in line with the Check of the Budget Estimates performed by Rigdon Construction.

Concern was expressed about the overall cost of the highway garage even as a phased project. It was the consensus that the documents be forwarded to Council members Brad Whicker and Larry Scott where were absent.

OTHER COUNCIL COMMENTS

The September Status of Funds was reviewed by the Council.

County Health Officer, Dr. David Stopperich stated that 86 of 92 counties had agreed to the Indiana Health Grants and thanked the Council for their support in approving their budget.

The Council acknowledged correspondence from Indiana Senator J.D. Ford and Indiana Representative Renee Pack regarding a Ronald Reagan Parkway intersection.

The Council acknowledged correspondence from Jazmyne Fitzwater.

Commissioner Phyllis Palmer remembered public servant Lydia Gibbs upon her passing. Larry Hesson stated she had served on the County Council two separate times and served as Hendricks County Assessor.

There being no further business to come before the Council, upon motion made by David Wyeth and seconded by Larry Hesson, the meeting was adjourned at 9:50 a.m. on Tuesday September 5, 2023. Motion carried 5-0.
