# HENDRICKS COUNTY COUNCIL REGULAR MEETING DECEMBER 19, 2023

The regular meeting of the Hendricks County Council was called to order by President Eric Wathen on Tuesday, December 19, 2023, with the following in attendance: Councilmen Caleb Brown, David Cox, Larry Hesson, Larry Scott, Eric Wathen, Brad Whicker, David Wyeth, Auditor Nancy Marsh, Financial Administrator Tami Mitchell, and Legal Counsel Rhonda Cook. Council President, Eric Wathen, led the assembly in the Pledge of Allegiance.

## IN THE MATTER OF THE NOVEMBER 8, 2023 REGULAR COUNCIL MEETING

It was moved by Brad Whicker and seconded by Larry Scott to approve the minutes of the November 8, 2023 Regular Council Meeting as presented. Motion carried 7-0.

#### IN THE MATTER OF PUBLIC COMMENT

Jarod McKee, Executive Director of Public Safety introduced the new Director of the Hendricks County Communication Center, Renee Tomlinson. The Council welcomed Ms. Tomlinson to Hendricks County and the Communication Center.

Human Resources Administrator Erin Hughes asked for the Council's authorization to allow Todd McCormack's position to become an INPRS covered position. Ms. Hughes stated laws had changed and the position would now be eligible. Commissioner Phyllis Palmer stated the position's benefits were negotiated by a former Commissioner. It was the consensus of the Council to allow the position to be covered by INPRS if it is eligible.

# IN THE MATTER OF THE AVON-WASHINGTON TOWNSHIP PUBLIC LIBRARY APPOINTMENT

Auditor Nancy Marsh stated the Council had received one application for reappointment to the Avon-Washington Township Public Library Board from Tina J. Stansbury and a letter of recommendation for Ms. Stansbury had been received from Laurel Setser, Library Director of the Avon-Washington Township Public Library Board. It was moved by David Cox and seconded by Larry Scott to appoint Tina J. Stansbury to the library board for a term ending December 31, 2027. Motion carried 7-0.

## IN THE MATTER OF THE PLAINFIELD-GUILFORD TOWNSHIP PUBLIC LIBRARY APPOINTMENT

Auditor Nancy Marsh stated the Council had received two application for appointment to the Plainfield-Guilford Township Public Library Board from Alyshia Ingram Busby and Elizabeth Giesting. Councilman David Cox stated both applicants were equally qualified and based on the years as a Hendricks County resident, it was moved by David Cox and seconded by Larry Hesson to appoint Elizabeth Giesting to the Plainfield-Guilford Township Public Library Board for a term ending December 31, 2027.

## IN THE MATTER OF THE PUBLIC DEFENDER

Hendricks County Chief Public Defender, Jeremy Gooch, discussed the upcoming capital murder case and the funding for the expenses of the case. Mr. Gooch stated he has consulted with the Hendricks County Public Defender Board and is authorized to request an appropriation for funds to apply toward the fees and costs of the defendant's legal representation. Mr. Gooch stated that he is requesting his remaining funds from the Public Defender's General Fund budget to be encumbered and applied toward the expense and to match that amount with funds from the Supplemental Public Defender Fund. Mr. Gooch additionally requested that the funds reimbursed from the State attributed to this new line be equally divided with a portion returned to the Supplemental Public Defender Fund.

The Council thanked Mr. Gooch and had no objection to his transfer and encumbrance plan which would be heard later in the meeting.

#### IN THE MATTER OF THE HEALTH BOARD APPOINTMENTS

Health Director Krista Click gave the Council some background to the new law regarding the Council's new authority to appoint a citizen Health Board member from the general public. Ms. Click recommended to the Council that they acknowledge the new requirements and postpone their appointment until next year when the current citizen appointment term expires on December 31, 2024. It was the consensus of the Council to acknowledge the new law under IC 16-20-2-5 and postpone the Council's appointment until January 1, 2025.

IN THE MATTER OF THE COUNCIL APPROVAL OF THE INTERLOCAL COOPERATION AGREEMENT BETWEEN TOWN OF AVON AND HENDRICKS COUNTY, INDIANA AND THE INTERLOCAL COOPERATION AGREEMENT BETWEEN THE CITY OF INDIANAPOLIS AND HENDRICKS COUNTY, INDIANA

County Engineer, John Ayers presented Resolution 2023-46 approving an interlocal agreement between the Town of Avon and Hendricks County and Resolution 2023-47 approving an interlocal agreement between the City of Indianapolis and Hendricks County. Council Attorney Rhonda Cook stated there are some issues to be worked out with the Commissioner's attorney and recommended the Resolutions be tabled until the issues are resolved. It was moved by Caleb Brown and seconded by David Wyeth to table Resolution 2023-46 and Resolution 2023-47. Motion carried 7-0.

#### IN THE MATTER OF THE 2023 INTO 2024 ENCUMBRANCES

Auditor Nancy Marsh presented the 2023 -2024 Encumbrances requested up to and including December 15, 2023. Auditor Marsh stated there may be a couple of stragglers that she will present and the January 2, 2023 meeting for the Council's ratification. It was moved by Caleb Brown and seconded by Larry Scott to approve the 2023 – 2024 Encumbrances as presented to date in the amount of \$38,684,438.80. Motion carried 7-0.

### IN THE MATTER OF THE SALARY ORDINANCE

Auditor Nancy Marsh stated the Salary Ordinance is not ready for signature as she has not received a report from Red Envelope regarding the performance increases.

### IN THE MATTER OF ADDITIONAL APPROPRIATIONS

Council President Eric Wathen opened and closed the public hearing with no comments being heard from the assembly.

Court Administrator, Catherine Haines, withdrew request #1. It was moved by David Cox and seconded by Brad Whicker to approve additional appropriation #2 through #5 as presented. Motion carried 7-0.

### **EMERGENCY APPROPRIATION RESOLUTION**

Whereas, certain extraordinary emergencies have developed since the adoption of the existing budget, so that it is necessary to appropriate more money than was appropriated in the annual budget; therefore, to meet such extraordinary emergencies;

#### **IN THE MATTER OF THE AUDITOR**

The Status of Funds was reviewed and noted that the fund balances and surplus funds remaining are very strong. Auditor Marsh stated the \$5,000,000,00 Food & Beverage receipt threshold has been met by the participating counties, therefore Hendricks County will receive the full 1% of the Food and Beverage Tax until the end of the fiscal year of June 30, 2024.

Auditor Marsh provided a 2023 Council Appointment list for the Council's review in making their 2024 appointments and a 2024 Council Calendar for their review before adopting at the January 2, 2023=4 meeting.

#### **OTHER BUSINESS**

Council Attorney, Rhonda Cook, presented the Engagement Letter of Cook Government Advisors, LLC for the Council's review and approval. It was moved by Brad Whicker and seconded by Caleb Brown to approve the Engagement Letter as presented. Motion carried 7-0.

Councilman David Cox expressed his concern about who has the authority to hire or fire the Financial Administrator position and he felt the employee should know who holds that power. Mr. Cox stated that he thought the issue should be clarified to avoid problems down the road. Councilman Larry Hesson stated he felt the position is responsible to the Council because the salary comes from the Council's budget. It was the consensus of the Council that further research and discussion be held at a later time.

Assessor Nikki Lawson asked for an official announcement on who was chosen to replace Tami Mitchell as Financial Administrator. Auditor Nancy Marsh stated Paula Alkire from the Auditor's Office was selected as the new Financial Administrator.

Assessor Nikki Lawson asked for clarification about when the department heads would be notified by the Council or Red Envelope, whether the performance increases they granted had been approved. Council President Eric Wathen stated that there will be no changes made by the Council or Red Envelope to the increases and the departments can share this information with their employees.

Court Administrator Catherine Haines asked for clarification on whether or not the performance pay stays with the employee when they move to another office. Auditor Marsh stated she and Council President have been working on a best practice plan to manage the wages in payroll. Council President, Eric Wathen, stated the performance pay stays with the person, but will need to be funded through the additional appropriation process initiated by the new office.

Council member Brad Whicker stated he would be absent from the January 2, 2024 meeting.

Council member Larry Scott stated he is actively participating in the Bicentennial Steering Committee, and they have many great plans made for the celebration. Mr. Scott stated their website is Hendricks 200.com. Mr. Scott stated there will be a newsletter coming out in April of 2024.

As this was Financial Administrator Tami Mitchell's last meeting, each Council member gave their personal thank you, congratulations and well wishes to Tami upon her upcoming retirement. Tami has worked in the Auditor's Office for 22 years with 16 years serving as Financial Administrator. She will be missed.

There being no further business to come before the Council, upon motion by Brad Whicker and second by Larry Scott the meeting was adjourned at 9:50 a.m. on Tuesday, December 19, 2023.
