A quorum was established; the Pledge of Allegiance was recited. Mr. Ayers made a motion to approve September 10th, 2025 meeting minutes. Mr. Kneeland seconded the motion.

Mr. Boyd went over the comments

- Most of the comments were addressed and notations were cleaned up
- Comments on the storm water are being addressed with the clean water permit
- The major issues were number 4 & 5. Loves is not in agreement with these.

Mr. Ayers: Went out and looked at the road and there were deficiencies throughout the road. There are no isolated areas, the entire road needs improvement.

Mr. Boyd: Loves wants their GEO tech to go out there and see if there is a way to repair the road without entirely ripping it up.

Mr. Ayers: The road will need to be done at some point, maybe we can talk about timing. The County can wait to do the road to the North, however, if both are doing the work at the same time there will be major traffic issues.

Mr. Boyd would like to make extensive notes with the county on what exactly needs to be fixed and coordinated at the start of construction to outline what needs to be fixed and cleaned up.

Mr. Dombrosky: Wants to make it clear that based on Loves push back on some other issues on the road, areas that need to be repaired are not for debate they are for the county to identify and coordinate for replacement. There is some time to figure out an exception so you can move ahead with the parking lot work in the Spring. Recommends approval subject to staff recommendations and if Loves does not agree they will have to come back in front of Plan Commission to appeal the decision.
