RE: HENDRICKS COUNTY SURVEYOR DAVID GASTON:

Joint Hendricks County & Morgan County Drainage Board meeting

Hendricks County Surveyor David Gaston stated the Morgan County Drainage Board had agreed to a Joint Drainage Board meeting at the Drainage Board's convenience to discuss the Alfred Cox Regulated Drain (459). Mr. Gaston reminded the Board that the members from Hendricks County were Mr. Stan Ryland and Mr. Bob Gentry. The Joint Board had requested that Hendricks County Attorney Greg Steuerwald serve as the Joint Board's attorney. Mr. Steuerwald agreed to serve in that capacity. Discussion followed. Mr. Gaston stated he would work out a date with Morgan County's Surveyor Terry Brock and report back.

GDIF Fund Transfer to the Town of Avon for Regulated Drains

Mr. Gaston stated that GDIF funds in the amount of 1,098,250.57 for the regulated drains transferred to the Town of Avon had been sent. Discussion followed.

Barnett Regulated Drain

Mr. Gaston stated Hendricks County Deputy Surveyor Cory Gehring had contacted Mr. Kent Dunbar and sent certified letters to the rest of the parcel owners along the proposed Barnett Regulated Drain project. Mr. Dunbar was agreeable to the project taking place while crops were in place. Mr. Gaston stated his office would wait to hear from the rest of the parcel owners before letting the project for quotes.

Henry Parker Reconstruction, Certification, & Assessment Roll

Mr. Gaston presented the Board with the Henry Parker Reconstruction, Certification, and Assessment Roll for their review and approval. Member Bob Gentry moved to approve the Henry Parker Reconstruction, Certification, and Assessment Roll as presented. Member Jack Maloney seconded the motion. The motion was unanimously approved.

Indiana Department of Transportation Projects

Mr. Gaston stated he, Deputy Surveyor Cory Gehring, Inspector Tiffany Dalton, INDOT's District Bridge Asset Engineer Chris Wheeler, and Technical Service Director Bill Smith had a very productive meeting about current and upcoming projects. Mr. Gaston asked Mrs. Dalton to update the Board on the outcome of the meeting. Mrs. Dalton stated INDOT had cleaned out the ditch along US 136 just south of the Rolling Hills Subdivision and the project looked very good. Mrs. Dalton stated INDOT had agreed to work on the French-Jegar Regulated Drain culvert that passes under Interstate 74. Currently the culvert stays ½ to ¾ full most of the time. INDOT has agreed to pump it out and analyze the situation. Mr. Gaston stated his office was working with INDOT to replace the McVey Regulated Drain tile along State Road 75 which was not functioning properly. Mr. Gaston said a request had also been made for a permit to video the Quinn Regulated Drain under 56th Street.

RE: IN THE MATTER OF WISHES TO BE HEARD:

Earl Arnold & John Warnock Regulated Drains

President Whetstone recognized Jake Arthur. Mr. Arthur stated he was representing himself and Mike Hession concerning the Earl Arnold & John Warnock Regulated Drains. He stated near the Hession property, water was pushing up from the Earl Arnold & John Warnock Regulated Drain. He thought it might be caused from the new dual pipe that had been put in near the drain. Discussion followed. Mr. Gaston said he would send out a video team as soon as it was dry enough to view the tile. Member Jack Maloney said the Minnesota Unlimited Crew that put in the new pipe was still in the area and he would contact them and have them look at the situation as well. Member Bob Gentry stated that the Earl Arnold needs its own outlet. Discussion followed.

Bob Gentry: Drainage Issues

Member Bob Gentry stated Mr. Dan Smith was having a drainage issue near his property on CR 500 E and one mile south of CR 1000 North. He stated the water is not moving and it appears the tile had broken down in the road-right-away. The owner is going to expose his private tile and video it. Mr. Gaston stated he would have an inspector review the area.

Member Bob Gentry said there was an erosion issue at CR 151 West & the CSX Rail Road. Mr. Gaston said he would have an inspector review the area. Discussion followed.

Member Bob Gentry stated there was an issue on the Lingerman Hardin Regulated Drain at 2125 CR 800 East. Mr. Gaston stated that area now falls under the Town of Avon responsibility. Discussion followed.
