# RE: HENDRICKS COUNTY ATTORNEY GREG STEUERWALD:

Hendricks County Attorney Greg Steuerwald stated that the Hold Harmless agreement for the Fairway Hills Homeowner Association was ready for approval. Discussion followed. Vice President Whetstone moved to approve the Hold Harmless agreement as presented. Member Bob Gentry seconded the motion. The motion was unanimously passed.

# RE: HENDRICKS COUNTY SURVEYOR DAVID GASTON:

# Wellington Ridge Regulated Drain

Hendricks County Surveyor's Office Inspector Dirk Leonard stated because of a concerned filed, he found that while the west end of the drain at Wellington Ridge was working that the old four-inch clay tile running to the east was completely unusable. Discussion followed. Member Bob Gentry moved to let the project for quotes and possible Easement acquisition. Vice President Whetstone seconded the motion. The motion was unanimously passed.

# Farmbrook Regulated Drain

Inspector Leonard said that he recently inspected the Farmbrook Drain because of a concern filed with the Surveyor's Office. He found a blow hole, severe erosion and flattening of the open drain. Discussion followed. Member Jack Maloney moved to let the project for quotes. Member Bob Gentry seconded the motion. The motion was unanimously passed.

# **Daniel Kennedy Regulated Drain**

Inspector Blake Stephenson stated upon inspection of the Daniel Kennedy Regulated Drain he found the portion that traversed the wooded area on the Carman property was full of tree roots and blocked. Discussion followed. Member Stan Ryland moved to let the project for quotes. Member Bob Gentry seconded the motion. The motion was passed on a 4-0-1 vote with Member Jack Maloney recusing himself. Vice President Whetstone requested that Inspector Stephenson make in person contact with the Carman's and let them know what was transpiring. Mr. Stephenson said he would contact them.

#### Joshua Tharp Regulated Drain – Sealed Quote

Chief Deputy Dalton informed the Board that 3 sealed quotes had been received for the Joshua Tharp Regulated Drain project. President Palmer requested the quotes be opened. The quotes were as follows.

Arthur's Excavating & Farm Drainage	\$ 32,258.00
Beechwood Excavating	\$ 43,477.00
Murrain Excavating	\$ 63,900.00

After reviewing the estimates Chief Deputy Dalton stated that while Arthur's Excavating's quote was not as detailed as it should be it was the lowest responsible quote at \$32,258.00. Discussion followed. The Board asked that Deputy Dalton inform Arthur's Excavating to be more thorough and detailed in its future submissions.

Member Bob Gentry moved to follow the recommendation. Member Stan Ryland seconded the motion. The motion was unanimously passed.

The Board was presented with the proposed 2021 Drainage Board schedule, Discussion followed. Member Bob Gentry moved to accept the schedule as presented. Member Jack Maloney seconded the motion. The motion was unanimously passed.

## Starkey Addition and Northern Acres Reconstruction Assessments

Hendricks County Treasurer Shawn Shelley presented the Board with documents showing 3 Parcels that still needed to finish paying on their reconstruction assessment from the Starkey Addition and Northern Acres Subdivision reconstruction project. She said only 1 of the 3 had paid all of the original assessment and most of the penalties and interest, while the other two had not paid any of the assessment or interest. Discussion followed. Treasurer Shelley asked the Board to waive penalties and interest if the original assessment was paid by December 31<sup>st</sup>, 2020. Discussion followed. Vice President Whetstone moved to remove the penalties and interest from the 3 parcels as long as the original assessment was paid by December 31<sup>st</sup>, 2020. However, if it was not paid, he moved that the full amount be set up for collections as of January 1, 2021. Member Bob Gentry Seconded the motion. The motion was unanimously passed.

#### Michael Martin Dugan Regulated Drain
