President Larry Hesson led the assembly in the Pledge of Allegiance.

IN THE MATTER OF THE AGENDA

Nancy Johnson made the motion to approve the agenda as presented. Myron Anderson seconded the motion. Motion carried 5-0.

IN THE MATTER OF THE MINUTES

Myron Anderson made the motion to approve the Council minutes as amended. Jay Puckett seconded the motion. Motion passed 5-0.

IN THE MATTER OF THE COMPREHENSIVE FINANCIAL PLAN

Greg Guerrettaz, Financial Solutions Group, presented his proposal for the 2010 sustainability analysis. He requested the 2009 revenues and expenditures from the Auditor to update the 2009 sustainability analysis. He would also prepare a sustainability analysis for 2010. He also suggested speaking with each department head to discuss possible ways to increase revenues and cut expenditures. He discussed the need for strategies in handling circuit breaker shortfalls. He suggested the need for a good plan for Economic Development. Jay Puckett made the motion to approve the preparation of a 2010 sustainably analysis. IN THE MATTER OF THE HEALTH DEPARTMENT- H1N1

Monica Smith, Director of Nursing, reported that flu cases in January and February were lower than expected. She reported that Hendricks County gave 37,000 H1N1 shots. Ms. Smith, on behalf of the Health Department, wanted to recognize Sara Thompson, Public Health Preparedness Coordinator for her hard work. She asked that a bonus of \$2,500 be given to Ms. Thompson for her efforts. President Larry Hesson asked that the request for the additional be deferred to the appropriate time in the meeting.

IN THE MATTER OF HUMAN RESOURCES

Ron Love, Human Resources Director, presented a requisition from Circuit Probation to replace an open probation officer position. Gwyn Green, Circuit Probation Director, told the Council of the increase in workload because of the changes at the state. Mr. Hesson asked that the new employee be informed that the position may not be permanent. Myron Anderson made the motion to approve the requisition. Dick Thompson seconded the motion. Motion passed 5-0. A requisition was presented to fill an opening for a female officer in the jail. Jay Puckett made the motion to approve the requisition. Nancy Johnson seconded the motion and the motion passed 5-0. Mr. Love told the Council that the Clinic opened on March 1 and was going very well. Mr. Love also discussed the problems that employees had with the new mail order prescription company, Orchard Pharmaceutical Services. Problems have been resolved and each
