Agenda items labeled "**PETITIONER REQUESTS CONTINUANCE**" have a continuance request that will be heard by the Plan Commission at the hearing. The Plan Commission may or may not grant the continuance which means the agenda item may or may not be heard at this hearing. Please note that a petitioner may request a continuance at any time up to the hearing or at the hearing and, as a result, a continuance request may not appear on the agenda in all cases. The Plan Commission may itself continue an agenda item as may be found necessary. Call (317) 745-9255 if you have a question about the most current status of an agenda item.

Written objections to any item on the agenda may be filed with the secretary of the Plan Commission before the hearing. At the hearing, oral comments concerning each Public Hearing proposal will be heard. The jurisdiction of the Plan Commission is all of Hendricks County except the towns of Avon, Brownsburg, Clayton, Danville, Lizton, Pittsboro, and Plainfield. RULES FOR PUBLIC SPEAKING

1. *If you wish to speak regarding a specific case, please sign the correct sign-in sheet.*
2. *For each case, Petitioner will have 15 minutes to make a presentation.*
3. *When the Public Hearing portion for each case is opened, please give your name and address at the podium and speak for no more than 3 minutes, or up to 10 minutes if you are representing a group. Discourteous, disorderly or contemptuous conduct shall be regarded as a breach of courtesy. Comments made by remonstrators shall be directed to the Commission and not to the applicant or any other person.*
4. *Every person appearing before the Commission shall abide by the directions of the President.*
5. *The Petitioner will have the opportunity to respond to remarks made by a remonstrator and answer additional questions from the Commission.*
6. *Once all testimony is taken, the public portion of the hearing is closed, and no further testimony will be taken.*
7. *The Commission may ask questions at any time of the Remonstrators or the Petitioner.*
