IN THE MATTER OF THE HENDRICKS COLLEGE NETWORK CONTRACT TERMINATION

Larry Hesson moved to approve items # 2, # 3 and # 4. Nancy Johnson seconded the motion. Motion passed 7-0.

IN THE MATTER OF REALLOCATIONS

Nancy Johnson moved to approve item # 1. Dick Thompson seconded the motion and the motion passed 7-0. Myron Anderson moved to approve item # 2 and # 3. Brad Whicker seconded the motion. Motion passed 7-0. Brad Whicker moved to approve items # 4 thru # 7. Caleb Brown seconded the motion. Motion passed 7-0.

OTHER COUNCIL BUSINESS

Council reviewed the information received from Randy Gomez, Nyhart, to provide a full GASB 45 update for 2013 and an update for 2015 for \$6,300. The Nyhart contract has been added to the Commissioner's November 26th meeting.

Council discussed a letter from Ms. Catherine Haines, Court Administrator, requesting to be excluded from the 2% salary increase for 2014. Larry Hesson moved to refuse her request. Dick Thompson seconded the motion. Motion failed 3-4, with Myron Anderson, Caleb Brown, Nancy Johnson and Brad Whicker dissenting.

Council acknowledged receipt of a tort claim from Keffer and Barnhart.

Ms. Kattau provided Council with copies of stop payment orders from the North Salem State Bank waiving all fees for the Child Support and Trust accounts for the Clerk's Office.

William Roche, Superintendent Parks & Recreation, told Council Mr. Robert Neimeyer wishes to be reappointed to the Park Board. Nancy Johnson moved to approve the reappointment. Dick Thompson seconded the motion and the motion passed 7-0.

Council acknowledged the election of Larry Hesson to Treasurer of the AIC effective November 1.

Commissioner President Phyllis Palmer told the Council there would be no County Christmas party and employees released from work at noon on Christmas Eve. She also stated the County employee service awards would be given at the Board of County Commissioners meeting on December 31.
