#### HENDRICKS COUNTY PROBATION COGNITIVE SKILLS CLASS



The concept of the Class is to focus on the thought process related to criminal activity and to try to change that process. Accepting responsibility for actions without blaming others is an essential component of the classes. A standardized and validated curriculum is used, which includes a workbook for the group participants. Instructors have been certified by a national organization in the use of curriculum and group facilitation.

Classes for Adults will be held in a Classroom at the Hendricks County Work Release Facility, located at 200 E. Campus Blvd., Danville, Indiana. The building is located just to the Southeast of the Hendricks County Jail, off of old U.S. 36. The building is a large pink colored brick building. Parking is available in the parking lot in front of the building. Classes for Juveniles will be held at 101 West Marion Street, Danville, IN 46122, in the Probation Building.

# These classes will be held one time per week for 6 weeks. Each class will be a 2 hour session.

These classes will focus on: values, attitudes, responsibility, trust, dealing with stress, being in control, the effects of alcohol and drugs on behavior, who is a criminal, and understanding the effects of the crime on the victim and society.

The cost of the class is \$50.00, paid at the Hendricks County Clerk's office, and includes a workbook and other necessary materials.

You must cancel 48 hours in advance of the class via your probation officer or by emailing:

You should arrive by 15 minutes prior to class time. Late attendees will not be admitted.

You will not be admitted if you are under the influence of alcohol or other drugs.

Registration is on a first-come, first-served basis. When the class is full, no other registrations will be accepted, and registration will be determined by the date the registration is received.
