Stormwater Ordinance and Technical Standards

Hendricks County Surveyor David Gaston asked the Board if they had any questions or concerns about the new Stormwater Ordinance and Technical Standards. Member Stan Ryland asked how difficult it would be to change the Technical Standards if needed. Mr. Gaston stated that the Ordinance and the Technical Standards are two (2) separate documents. The Ordinance can only be amended or revised by the County Commissioners. The Technical Standards can be amended or revised by the Hendricks County Drainage Board at any public meeting; Discussion followed. Member Jack Maloney moved to approve the Stormwater Ordinance and Technical Standards and send them to the Commissioners for consideration. Member Stan Ryland seconded the motion. The motion was unanimously approved.

Hendricks County Drainage Board – 2024 Meeting Schedule

Mr. Gaston stated that the 2024 Drainage Board meeting schedule was in the Board binders for review. Discussion followed. Member Jack Maloney moved to adopt the 2024 meeting of holding the Drainage Board meetings on the second and fourth Tuesday of each month unless otherwise specified and omitting the second meeting in December. Member Stan Ryland seconded the motion. The motion was unanimously approved.

Austin Winds Regulated Drain

The Board was informed that the Austin Winds Regulated Drain project had received three sealed quotes. President Gentry requested they be opened. The quotes were as follows:

After reviewing the quotes, Chief Deputy Tiffany Dalton recommended Beechwood Construction, which had the lowest responsive and responsible quote at \$17,113.00. Discussion followed. Vice President Palmer moved

to follow the recommendation. Member Jack Maloney seconded the motion. The motion was unanimously approved.

Verdant Acres Regulated Drain - North & South

The Board was informed that although all the contractors on the Surveyor's list had been notified and the project had been posted on the Surveyor's website, only one sealed quote had been received for the Verdant Acres Regulated Drain North and South project. President Gentry requested that it be opened. The quote was as follows:

Murrain Excavating \$102,900.00

After reviewing the quote, Chief Deputy Tiffany Dalton recommended Murrain Excavating, which had the lowest responsible quote at \$102,900.00. Discussion followed. Member Jack Maloney moved to follow the recommendation. Member Dennis Dawes seconded the motion. The motion was unanimously approved.

Oakley Regulated Drain - Phase 1

The Board was informed that although all the contractors on the Surveyor's list had been notified and the project had been posted on the Surveyor's website, only one sealed quote had been received for phase one of the Oakley Regulated project. President Gentry requested that it be opened. The quote was as follows:

Alexander Contractors

\$65,026.24

After reviewing the quotes, Chief Deputy Tiffany Dalton recommended Alexander Contractors, which had the lowest responsive and responsible quote at \$65,026.24. Discussion followed. Member Stan Ryland moved to follow the recommendation. Member Jack Maloney seconded the motion. The motion was unanimously approved.

Oakley Regulated Drain - Phase 2

The Board was informed that the Oakley Regulated Drain project had received two sealed quotes. President Gentry requested they be opened. The quotes were as follows:

Murrain Excavating

\$69,899.00

After reviewing the quotes, Chief Deputy Tiffany Dalton recommended Alexander Contractors, which had the lowest responsive and responsible quote at \$64,664.57. Discussion followed. Member Dennis Dawes moved to follow the recommendation. Member Jack Maloney seconded the motion. The motion was unanimously approved.
