RE: HENDRICKS COUNTY SURVEYOR DAVID GASTON:

Logiam Discussion

Hendricks County Surveyor David Gaston brought to the attention of the Board the logjam problem in Brownsburg. President Bob Gentry asked Eric Wathen to share information regarding Brownsburg's process for handling drainage situations where no funds were available. Discussion followed. The Board requested for Mr. Gaston to send out a letter to Trees R Us Inc. about keeping cut wood out of the floodway area of White Lick Creek.

Logiam removal line item on the Commissioners Budget

Mr. Gaston informed the Board that it was his understanding that Mr. Ayers is planning to request a line item in his budget for next year in order to deal with non-regulated drain issues and drainage problems

outside of the county road right-of-way. He said that he would speak with him regarding this situation. Discussion followed.

Drainage Board 2017 Budget

Mr. Gaston brought to the Board's attention that the 2017 Drainage Board budget was located under the attachment page in their binders. Vice President Phyllis Palmer asked to compare last year's budget to the current budget. Mr. Gaston said he would send it to her. Vice President Palmer moved to approve the 2017 Drainage Board budget. Member Jack Maloney seconded the motion. The motion was unanimously passed.

Batz Arm 1 – Update

Mr. Gaston presented an update of the Batz Arm 1. He made the Board aware that Banning Engineering had completed the field work on this arm and was now preparing a plan and profile for the Board's review.

Miscellaneous

Mr. Gaston introduced Andre Heath of the Hendricks County Surveyor's Office. Mr. Gaston also wanted to let the Board know that he is proud that the last two (2) employees hired by the Surveyor's Office are veterans of the Marine Corps.

RE: IN THE MATTER OF WISHES TO BE HEARD

President Gentry recognized Bruce Williams of 10426 E. Co. Rd. 200N. Indianapolis, IN. 46234. Mr. Williams stated that there is a drainage concern along the north side of County Road 100 North in Avon. The water that is coming from the west to the road culvert overtops the county road under heavy storms. Mr. Williams informed the Board that he thinks a larger culvert would solve the problem. Discussion followed. Mr. Gaston stated that he would speak with John Ayers and Ryan Cannon of the Town of Avon about the issue and try to keep Mr. Williams informed.
