**Application Deadline:** Date by which a plan commission application must be filed to be heard the next month. The Surveyor's Office uses the same deadline for Drainage Board applications.

**Site Visit:** The date staff will visit the project site. A notice of the hearing may be posted on the site.

**Public Notice Deadline:** Date by which the legally required public notice must be submitted. This is done by staff.

**TAC Review:** The date the Technical Advisory Committee reviews the application with the applicant. Unless other arrangements are made, the applicant is required to attend.

**Preliminary Consultation:** An informal meeting between staff and a prospective applicant to discuss the feasibility of a project.

**Written Notice Deadline:** Date by which the applicant must have mailed notice to nearby property owners.

**Plan Commission Hearing:** Date of the Plan Commission hearing.

**A&P Committee Hearing:** Date of the Administrative and Plat Committee hearing.
