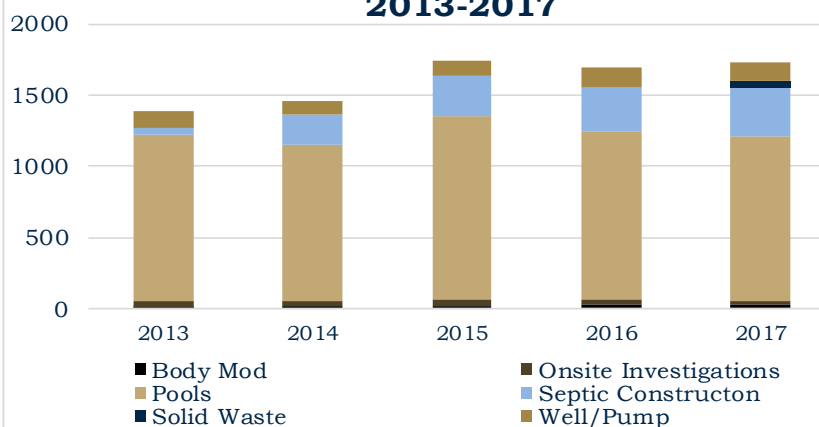

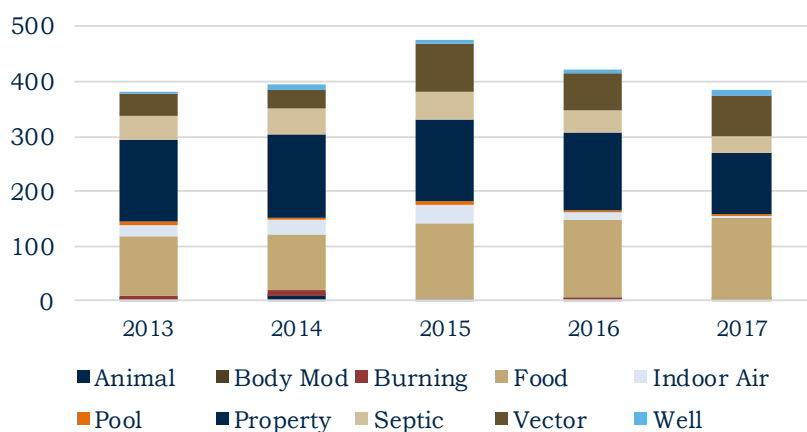
Environmental Permits Issued 2013-2017

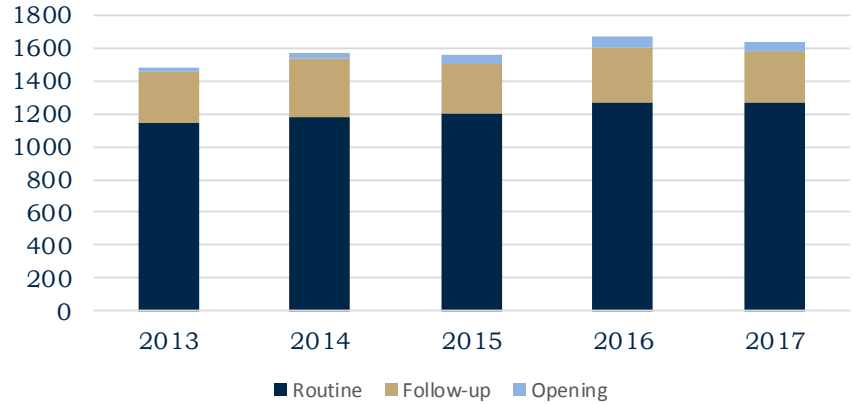

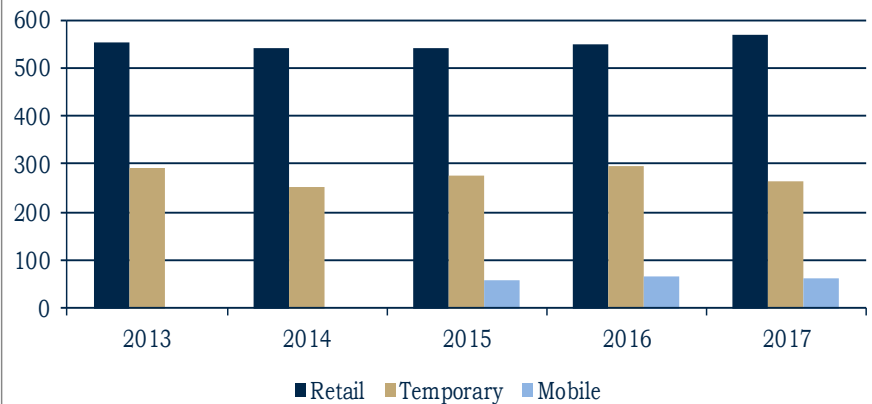

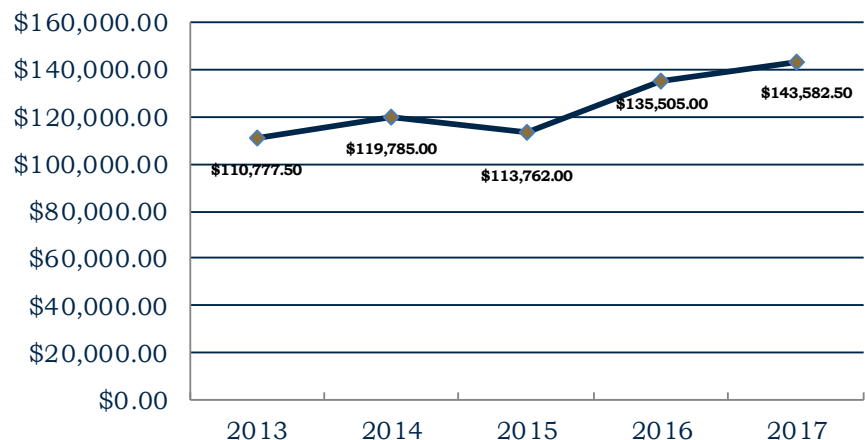

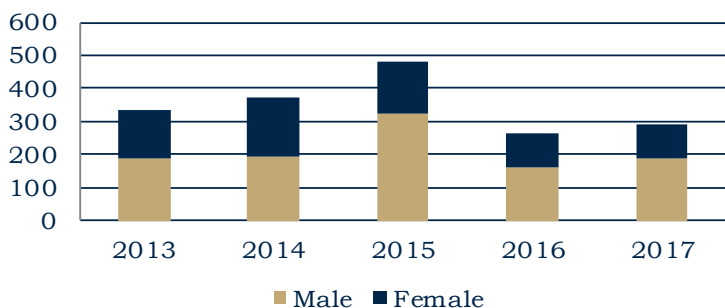

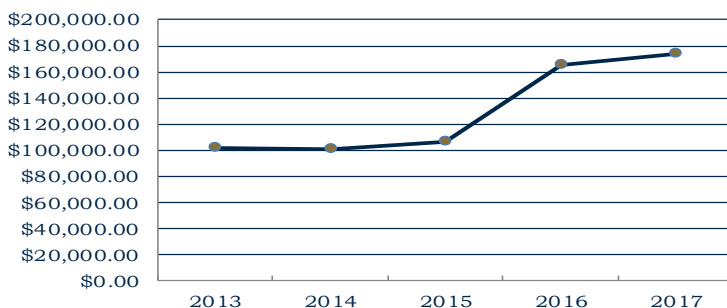

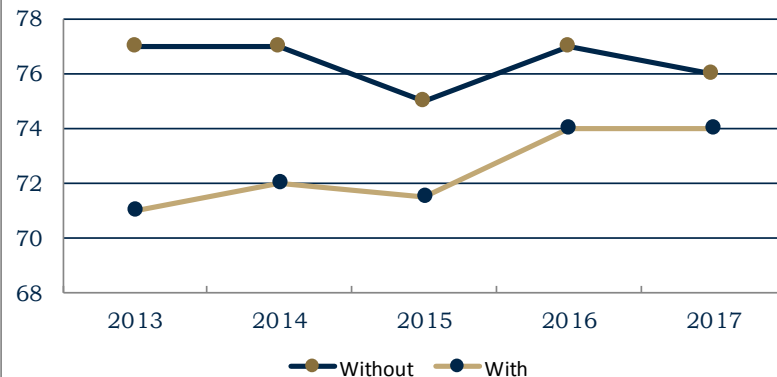

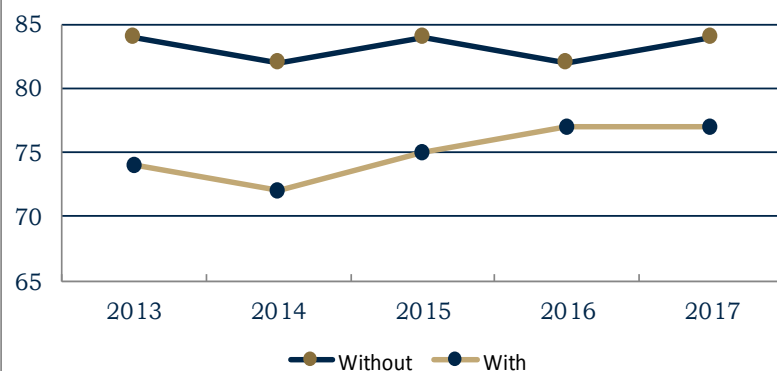

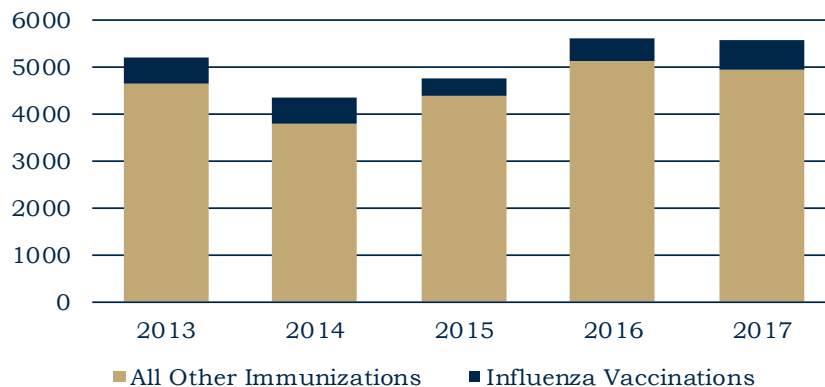

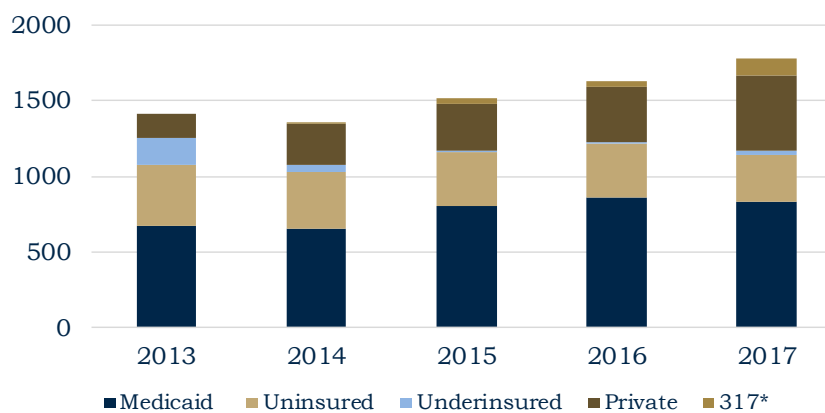

Immunizations Given Through Health Department 2013-2017

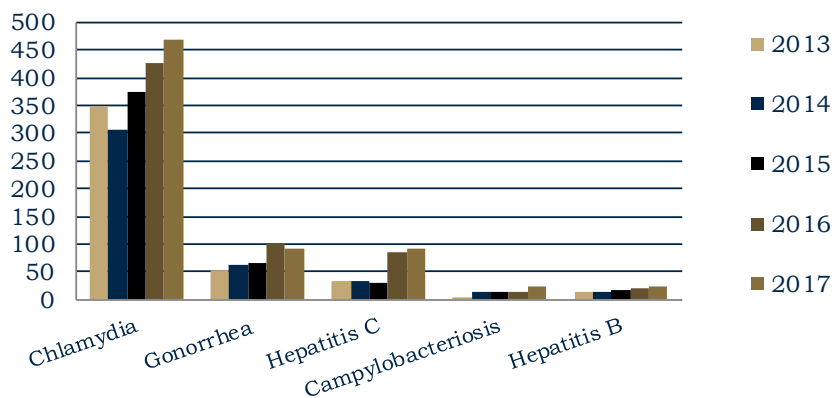


2013-2017 Patients by Eligibility Groups

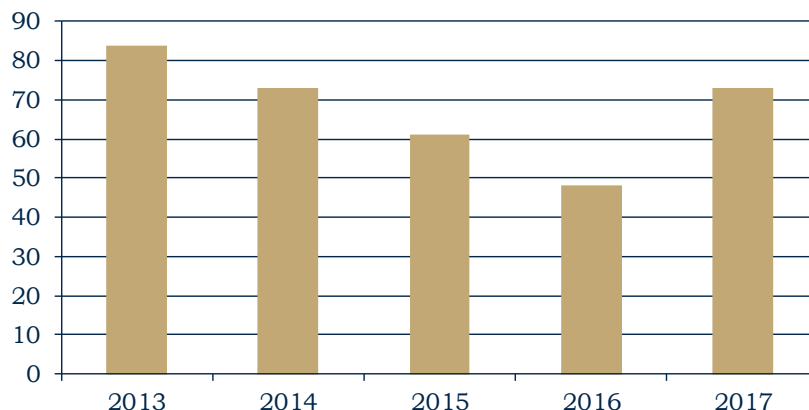

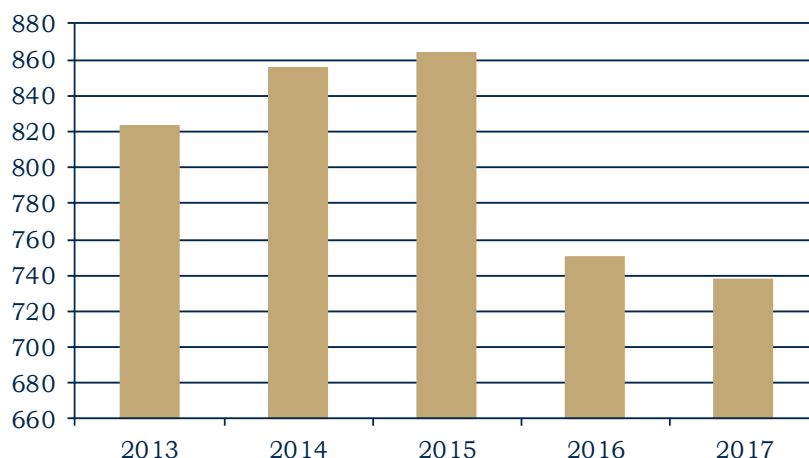

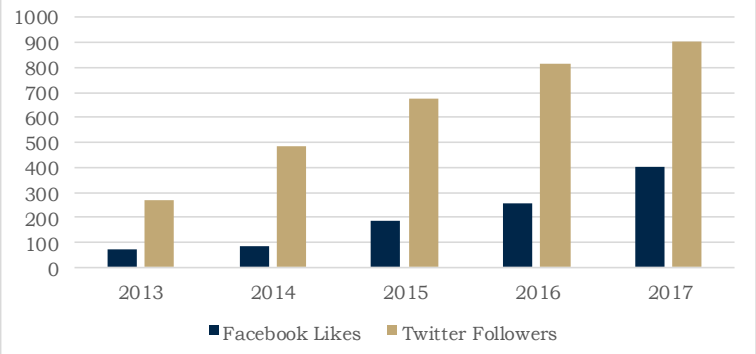

Work Group Updates

Each work group has made progress on their portion of the 2016-2018 Community Health Improvement Plan. Strategies completed in 2017 are listed below.

Accessing and Utilizing Health Care

- Developed a resource guide of all Hendricks County primary care providers. Disseminated to key organizations and locations throughout the county.
- Began work on identifying three key messages related to health literacy to assist residents in developing an understanding of basic health information and services, in order to make appropriate health decisions. Key messages include, when to use an ER versus when to use urgent care, and “zone sheets” for common health conditions. Educational messaging materials are in the process of being completed.

Mental Wellness

- Helped create a Mental Health Provider Resource Guide with Mental Health America of Hendricks County.
- Worked with a local writer and graphic designer to create messaging regarding mental wellness and suicide prevention. These flyers will be distributed on social media and through key community partners such as schools.
- Identified screening tools, crisis intervention services, and training protocols for primary care providers with the goal to train 50 primary care providers serving Hendricks County on suicide prevention screening and immediate referral.

Substance Abuse

- Developed a comprehensive Central Indiana Substance Abuse Treatment Resource Guide. Disseminated resource guide to key community members and the general public.
- Trained 138 Hendricks County laypersons in need of Naloxone on recognizing and responding to opioid overdose and equipped them with needed resources.

Physical Activity and Nutrition

- Data gathered regarding shared use policies for schools in Hendricks County. A “Why Open Use” resource packet was created for Hendricks County schools to utilize to promote access to physical activity resources.
- “Prescription” pads distributed to encourage recommended amount of physical activity and increased consumption of fruits and vegetables. These sheets were given during YMCA wellness visits and at Partners in Care.

Tobacco Use

- Developed a coalition committee to address capacity building and community member involvement.
- Meetings held with health care providers, community agencies, and/or employers who are not currently Preferred Providers with the Indiana Tobacco Quitline.
- Meetings held with local and state elected officials sharing information about tobacco control activities.

Preparedness Activities

- Updated Memorandum of Understanding (MOU) for all active Points of Dispensing (POD) sites. These sites consist of four schools (Avon High School, Brownsburg East Middle School, Danville High School and Plainfield Middle School) and the Hendricks County Fairgrounds.
- Walkthroughs completed and maps updated of all active POD sites. Each site is unique and it is critical to plan the most efficient routes in regards patient and staff entrances, exits and parking. These elements are all displayed on a maps that will be available when at the site.
- Began work on CDC DCIPHER program. This is the federally mandated computer program to manage and organize the medical countermeasures plan.
- Participated in Kids Fair/Preparedness Fair. This fair highlighted recruiting for the Medical Reserve Corps and displayed the supply trailer. The supply trailer holds all of our supplies required to set up a Point of Dispensing site, including signage, maps, office supplies and other materials.
- Updated Radio Inventory. A cache of radios is maintained by the Preparedness Coordinator. The AM radio station would be used to communicate messages to the public over an AM radio frequency. In addition there are (6) 800 MHz radios to communicate with local fire, local police and agencies on Public Health channels. The inventory also includes 24 radios used for communications within our Points of Dispensing.



Community Group Partnerships

- Hendricks County School Safety Commission. The group is comprised of members of each school safety and law enforcement personnel, Emergency Management, and the Prosecutors office. Various school safety issues are discussed as well as programs presented to enhance the safety of the schools in Hendricks County.
- District 5 Local Health Departments Preparedness and District 5 Healthcare Coalition. Monthly meetings are for networking and training for all the Public Health Preparedness Coordinators. The District 5 Healthcare Coalition is another monthly grant required meeting. This groups is made up of all Hospital, Health Department, Emergency Management and Emergency Medical Services professionals.
- Hendricks County Emergency Support Function (ESF) #8 Committee. The Preparedness Coordinator leads this group and brings all Healthcare resource representatives in Hendricks County together for quarterly meetings and training sessions.
- Local Emergency Planning Committee (LEPC). is a federally mandated group that meets quarterly for training and discussion related to hazardous materials in Hendricks County.
- Participated in Government Center Building Security Committee

Medical Reserve Corps

- Utilized a survey to restructure the Medical Reserve Corp (MRC) that resulted in an updated roster of volunteers
- The updated MRC roster resulted in 78 active participants. These volunteers can be utilized for various activities within the county
- Applied for a Challenge Award through the National Association of County and City Health Officials (NACCHO)
- Participated in a radio interview on WYRZ-FM to educate the public and recruit new MRC members



2017 Naloxone Rescue Kit Grant

Overview

The Hendricks County Health Department was awarded 50 Nasal Naloxone Rescue Kits through a grant from the Indiana State Department of Health in late 2016. 36 more Rescue Kits were awarded in 2017. The goal of this program is to provide free nasal Naloxone and overdose reversal training to Hendricks County laypersons who are in close contact with someone struggling with opioid addiction, or someone who is recently in recovery. Indiana Code 16-42-27 allows for local Health Departments to operate under a standing order to train laypersons how to use Naloxone.

Several laypersons with a loved one struggling with addiction, were trained and provided with a dose of Naloxone. Health Department staff also trained numerous high school and middle school nurses, motels/hotel managers and other various community agencies and businesses working with higher risk populations. All trainings included how to recognize an overdose, and the use of Naloxone.



In order to receive training, a layperson must contact the Health Department to set up a training appointment with a Public Health Education Specialist. Appointments are 15-20 minutes long. Larger scale on site trainings for community agencies and businesses are also offered.

2017 Grant Activity Highlights

- Trained 138 Hendricks County laypersons in total during 2017.
- Trained representatives from each school corporation in the county (i.e.: school nurses, administrative staff, maintenance staff)
- Participated in television interviews on FOX-59 and WRTV-6 about the program
- Presented at Plainfield High School's "Parent Forum on Addiction" about resources related to substance abuse
- Hosted an Overdose Reversal Training for community agencies
- Trained representatives from 12 various community service organizations, including managers of 2 truck stops and the managers/staff of 3 high risk hotels
- Hosted a Community Overdose Reversal Training for the public at Fairbanks Plainfield Outpatient Office
- Advertised the program through working with local fire departments, community agencies and businesses, and attending fairs and events such as the Drug Free Family Night hosted by the Substance Abuse Task Force
- Spoke at Leadership Hendricks County's Community Conversations Day with Sherriff Clark about substance abuse
- Participated at a round table event hosted by the Willow Treatment and Recovery Center. Senator Donnelly was also a participant.

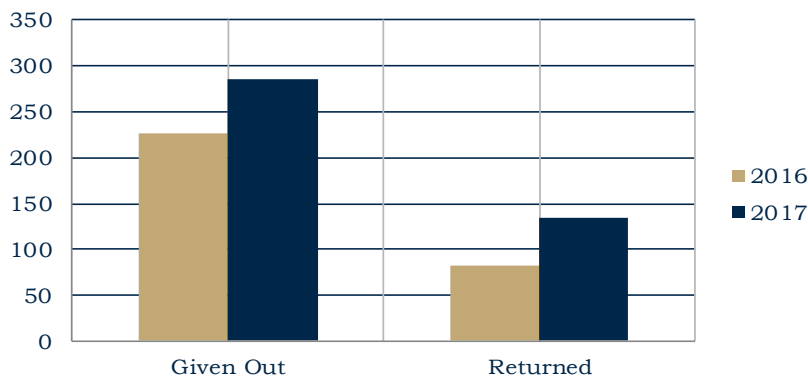

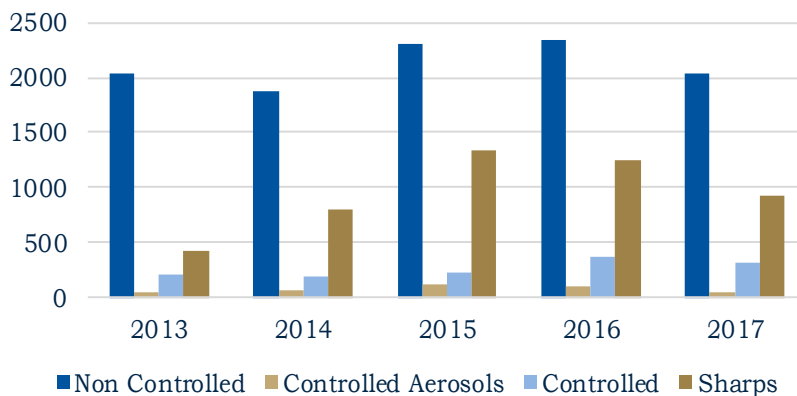

Overview

The Hendricks County Baby & Me - Tobacco Free Program was awarded \$42,543 for Fiscal Year 2017. The Hendricks County Health Department provided a 30% match from Child Health funds of \$13,486 in in-kind funding as well as funding for additional diaper vouchers and testing equipment.

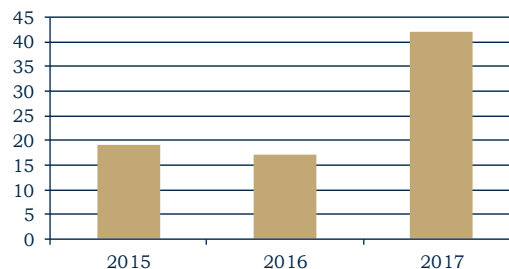
This evidence-based program provides 4 prenatal and 12 postpartum appointments to pregnant, smoking mothers. Participants are enrolled during pregnancy and must quit smoking before the baby is born. A \$25 diaper voucher is given at prenatal sessions 3 and 4 and all 12 postpartum sessions to mothers who successfully quit smoking.

Forty-two new participants were enrolled during 2017. This is a significant increase from the 19 participants enrolled in 2015 and 17 participants enrolled in 2016. In 2017, 4 participants successfully completed all 12 postpartum sessions and graduated from the program.

2017 Grant Activity Highlights

- 15 participants successfully completed all 4 prenatal sessions.
- 4 participants successfully completed all 12 postpartum sessions.
- Westside Physicians for Women and Morgan County WIC enrolled as Referral Partners.
- 63 referrals were made to the program by Partners In Care, Westside Physicians for Women, WIC, and MDWise.
- 16 Babies were born to Baby & Me Participants. All singleton births were born at 37 weeks gestation or greater and all birth weights were 6 lbs. 2 oz. or greater. No babies born to mothers actively enrolled in the program were born Pre-term or Low Birth Weight.
- The program was awarded \$50,000 for Fiscal Year 2018. This increased the amount of time spent on this grant by the Baby & Me Coordinator from 20 hours/week to 28 hours/week starting September 2017.
- The Program Coordinator started a satellite site in Morgan County to enroll additional Baby & Me participants. The Coordinator enrolled the first participants from Morgan County in December 2017.
