# IN THE MATTER OF UTILITY EASEMENT REQUEST FOR HENDRICKS COUNTY RURAL ELECTRIC MEMBERSHIP CORPORATION

Hendricks Power presented the proposed Utility Easement across the Fairgrounds property to allow Hendricks County Rural Electric Membership Corporation to connect to the new substation being constructed near the Hendricks County Jail and requested approval. The entire project will be done by directional underground bore with no disruption to the Fairgrounds property.

There was discussion amongst the members and Hendricks Power regarding the matter.

Jeffrey Smallwood moved to approve the Easement as presented. Dan Keers seconded the motion and the motion was approved unanimously 3-0-0.

#### IN THE MATTER OF OTHER BUSINESS

Kevin Cavanaugh reported another easement request may be coming from Endeavor Communications for the installation of a small concrete building on the southwest corner of the Fairgrounds property. The estimated area is twenty (20) feet by twenty (20) feet with a consideration to the County of \$3,500.00.

Steve Patterson reported the Antique Tractor Machinery Association would like to construct an approximate forty-eight (48) foot by forty (40) foot pole barn on the northwest side of the Fairgrounds property and will present more information on a later date.
