RE: HENDRICKS COUNTY SURVEYOR DAVID GASTON:

Gailcrest Regulated Drain

Hendricks County Chief Deputy Tiffany Dalton stated the Joe Miller of Banning Engineering was present to give recommendations on the Gailcrest Regulated Drain project. Mr. Miller said he had reviewed the site, and, in his opinion, there were 3 options.

- 1. Construct a new 2 x 2 inlet at upstream end with an East Jordan 6488O casting, remove the willow tree from in the current overflow and repair tile in that area.
- 2. Recommendation #1 above plus upsizing the existing tile to 18" or 15" whatever the ground cover would allow.
- 3. Recommendations #1 and #2 above plus re-grading the downstream grassed waterway through the property owned by Mr. Malcom Gohier (in attendance at this meeting) to carry any additional flow.

Disscussion followed. Vice President Palmer moved to let the project for quotes. Member Dennis Dawes seconded the motion. The motion was unanimously passed.

RE: IN THE MATTER OF WISHES TO BE HEARD:

Hidden Valley Regulated Drain

President Gentry recognized Mrs. Estelle Graham of Hidden Valley Subdivision. Mrs. Graham stated they were still having erosion issues at the entrance to the Hidden Valley Subdivision at Avon Avenue and Hidden Valley Drive. It was the Consensus of the Board to have the Hendricks County Surveyor and Engineering staff review the situation and come up with a solution.

RE: INTRODUCTION OF OTHER BUSINESS OR ADDITIONAL DISCUSSION BY BOARD MEMBERS:

Sunny Meadows Subdivision

President Gentry stated that he and Member Jack Maloney had been made aware of a drainage issue in the Sunny Meadows Subdivision. Member Jack Maloney described a way to solve the drainage issue. Discussion followed. Hendricks County Surveyor David Gaston made the Board aware that this was not a regulated subdivision. Chief Deputy Tiffany Dalton requested that if the Surveyor's Office staff were to get involved to do research and get quotes the staff would like one of the Board members to assist in writing the scope of work since it is not a regulated subdivision. Discussion followed. Vice president Palmer moved to let the project for quotes. Member Dennis Dawes seconded the motion. The motion was unanimously passed.
