## RE: IN THE MATTER OF OLD BUSINESS: PROJECTS

#### MAJOR PLAT (PRELIMINARY):

## S-9-21 (Bellwood formerly Millstone) – Avon

116 lots on 65.872 acres in Washington Township, S14-T15N-R1E, located on the southside of County Road 100 South, approximately 1,313 feet east of South Avon Avenue in the Town of Avon. (HWC Engineering) – Request to Vacate the upper end of the George Mercer Regulated Drain.

Hendricks County Surveyor David Gaston recommended the Hendricks County Drainage Board grant the Vacation request for the George Mercer Regulated Drain upper end where it entered the Bellwood project area. Discussion followed. Member Dennis Dawes moved to follow the Surveyor's recommendation. Member Jack Maloney seconded the motion. The motion was unanimously passed.

# **S-6-22 (Trescott) – County** (Being Annexed by Plainfield)

382 lots on 167.3 acres in Guilford Township, S10-T14N-R1E, located on the southside of County Road 600 South, approximately 826 feet west of County Road 675 East. (Banning Engineering) No Regulated Drain.

Hendricks County Surveyor David Gaston stated that this project was technically in the Town of Plainfield but outlet into an unincorporated part of the county. Per the Board's request, he had been working with the Project Engineer to reduce their stormwater release rate into the county. He had also requested a legal consult with Hendricks County Attorney Greg Steuerwald to see if the County had jurisdiction over the project. However, he was sufficiently satisfied with the release rates to recommend that the Board grant Preliminary Approval of *S-6-22 (Trescott)* subject to the conditions of the Hendricks County Surveyor's letter. Discussion followed. Member Dennis Dawes moved to follow the Surveyor's recommendation pending the legal guidance of the Hendricks County Attorney. Member Jack Maloney seconded the motion. The motion was unanimously passed.

# **Lingerman Regulated Drain**

President Gentry recognized Mr. Jeff Fox, a resident of Forest Commons. Mr. Fox stated that since the work on the Lingerman Regulated Drain through Forest Commons had commenced, he and his wife have noticed more water collecting on their property, and that after this week's heavy rain, the lower section was flooded. Mr. Gaston stated that according to the recorded plat, the lower section of their property was in the flood zone and would be prone to flooding during heavy storm events. President Gentry stated that he and Member Jack Maloney had walked the lower end of the Lingerman down to the county road and found some small blockages that were holding back water. Mr. Gaston stated that once the upper end project was complete, he would look at how to handle the lower end since it was not a regulated drain and neither the Board nor he had much authority to work in that area. The Board asked Mr. Gaston and David Eichelberger of Christopher Burke Engineering to investigate the situation and come back to the Board with a recommendation.
