WHEREAS, the Hendricks County Drainage Board has held a public hearing and has given consideration for the vacation of the <u>Hadley Hills, Hickory</u> <u>Ridge, Lazy Meadows, Matthews Meadows, Royal Acres, Southwind Estates,</u> <u>Walnut Creek Estates, and Williams Lake in the Woods Regulated Drains;</u> and

WHEREAS, the Hendricks County Drainage Board approved the vacation of the above Regulated Drains as presented by the Hendricks County Surveyor at the said hearing on July 26th, 2022;
