S-11-22 (INDOT DES. No. 1902063 I-74 Small Structure)

Culvert replacement in Lincoln Township, S1&12-T16N-R1E, located under Interstate 74, approximately 50 feet northwest of County Road 600 in the Town of Brownsburg. (RQAW) *Timothy Quinn Regulated Drain. No assessment recommended as this is an INDOT project.*

S-3-08 – Revision (Avon High School Renovations - #3902-6) – Avon

2 lots on 95 acres in Washington Township, S14-T15N-R1E, located on the southside of County Road 150 South, Approximately 1,364 feet west of Dan Jones Road in the Town of Avon. (Veridus Group) *Mercer Regulated Drain \$100.00 per acre Outlet Only.*

Hendricks County Surveyor David Gaston recommended the Hendricks County Drainage Board grant Preliminary Approval of *S-3-08 – Revision (Avon High School Renovations - #3902-6)* subject to the conditions of the Hendricks County Surveyor's letter, all the requirements and conditions of the Hendricks County Stormwater Management Handbook, and a \$100.00 per acre assessment payable to the Mercer Regulated Drain. Discussion followed. Member Dennis Dawes moved to follow the Surveyor's recommendation. Member Jack Maloney seconded the motion. The motion was unanimously passed.

S-22-03 (Brownsburg High School Renovations) - Brownsburg

1 lot on 14.3 acres in Lincoln Township, S14-T16N-R1E, located on the westside of South O'Dell Street at the southern terminus of Bulldog Boulevard in the Town of Brownsburg. (Veridus Group) Mary E. Wilson Regulated Drain \$100.00 per acre.

Hendricks County Surveyor David Gaston recommended Continuing *S-22-03 (Brownsburg High School Renovations)* to the October 11th, 2022, meeting of the Drainage Board. Jennifer Lasch of the Veridus Group asked if they could be granted preliminary approve as she felt they had met most of the conditions of the Hendricks County Stormwater Ordinance. Mr. Gaston stated they still had several issues that needed to be addressed. Discussion followed. The consensus of the Board was not to move forward with Preliminary Approval. Discussion followed. Vice President Palmer moved to Continue the project until the October 11th, 2022, meeting of the Drainage Board. Member Stan Ryland seconded the motion. The motion was unanimously approved.

MAJOR PLAT (PRELIMINARY & FINAL):

DPR 509 (Greensgroomer) – County

1 lot on 2.0 acres in Lincoln Township, S20-T16N-2E, located on the westside of North Raceway Road, Approximately 1,004 feet north of US Highway 136. (Bordenet) *No Regulated Drain*.

Hendricks County Surveyor David Gaston recommended Continuing *DPR 509 (Greensgroomer)* to the October 11th, 2022, meeting of the Drainage Board. President Gentry moved to Continue the project until the October 11th, 2022, meeting of the Drainage Board. Member Dennis Dawes seconded the motion. The motion was unanimously approved.

DPR 511 (Smyrna Concrete Plant) - County

1 lot on 10.66 acres in Liberty Township, S36-T14N-R1W, located on the southeast corner of Interstate 70 and State Road 39. (Banning Engineering) No Regulated Drain.

Hendricks County Surveyor David Gaston recommended the Hendricks County Drainage Board grant Preliminary and Final Approval of *DPR 511 (Smyrna Concrete Plant)* subject to the conditions of the Hendricks County Surveyor's letter, and all the requirements and conditions of the Hendricks County Stormwater Management Handbook. Discussion followed. Member Dennis Dawes moved to follow the

Surveyor's recommendation. President Gentry seconded the motion. The motion was unanimously passed.

S-06-21 - Revision (Crossroads Elementary School) – Brownsburg/County

1 lot on 29.946 acres in Lincoln Township, S13-T16N-R1E, located on the northside of Airport Road and the eastside of South Northfield Drive in the Town of Brownsburg. (Veridus Group) Timothy Quinn Regulated Drain \$100.00 per acre.

Hendricks County Surveyor David Gaston recommended the Hendricks County Drainage Board grant Final Approval of *S-06-21 - Revision (Crossroads Elementary School)* subject to the conditions of the Hendricks County Surveyor's letter, all the requirements and conditions of the Hendricks County Stormwater Management Handbook, and a \$100.00 per acre assessment payable to the Timothy Quinn Regulated Drain. Discussion followed. Member Jack Maloney moved to follow the Surveyor's recommendation. Member Dennis Dawes seconded the motion. The motion was unanimously passed.

RE: HENDRICKS COUNTY SURVEYOR DAVID GASTON:

John Lackey Regulated Drain

Hendricks County Surveyor David Gaston informed the Board that his office had received 2 sealed quotes for the John Lackey Regulated Drain project. President Gentry requested for the quotes to be opened. The quotes were as follows.

Murrain Excavating \$49,450.00 Arthur's Excavation \$74,515.00

After reviewing the quotes Inspector Blake Stephenson recommended Murrain Excavating as they had the lowest responsible quote at \$49,450.00. Discussion followed. Member Dennis Dawes moved to follow the recommendation. Member Stan Ryland seconded the motion. The motion was unanimously passed.

Preston Estates Surveyor Report

Mr. Gaston presented the Board with the Surveyor's Report for the Preston Estates Regulated Drain reassessment. He informed them that the Surveyor's Office could have everything ready to hold the reassessment hearing at the October 25th Drainage Board meeting. Chief Deputy Tiffany Dalton's report showed if the Board went with the current County standard drainage assessment of \$100.00 per lot it would take approximately 35 years to pay off the loan from the General Drain Improvement Fund, however if the assessment was raised to \$200.00 per lot, it would take approximately 18 years to pay off the loan. Discussion followed. Vice President Palmer asked if the Board could lower the assessment once the loan was paid off. Mr. Gaston stated there was precedent for that action. Member Jack Maloney moved to accept the Surveyor's report

with an amended assessment of \$200.00 per lot and set the hearing date for October 25th, at 8:00. Member Dennis Dawes seconded the motion. The motion was unanimously passed.

Danville Conservation Club Dam Regulated Drain

Hendricks County Inspector Dirk Leonard stated that Banning Engineering had to make several changes to the Scope of Work and contract for the Danville Conservation Club Dam project due to finding more damage than was originally estimated. There were several voids found requiring entire sections of concrete to be removed, however some of the sections would be replaced without a stone base, but instead would be set deeper and on compacted soil. The Board thanked Inspector Leonard and asked him to keep them appraised of the project.

Certification of Assessments, splits, and transfers, Suspension of Assessment recommendations, Reactivation of Assessment recommendations for regulated drains.

Mr. Gaston informed the Board that they would find the lists for Certification of Assessments, splits, transfers, Suspension of Assessment recommendations, and Re-activation of Assessment recommendations for regulated drains in their binders. He asked them to take them under advisement for the October 25th meeting of the Drainage Board as they needed to be in the Auditor's Office by November 1st. The consensus of the Board was to take them under advisement.

Stratford of Avon

Mr. Gaston informed the Board that the Taulman lawsuit in Timber Bend was still in progress and would be going to court on October 24th and 25th. The Board thanked him for the update.
