RESIDENT FEE

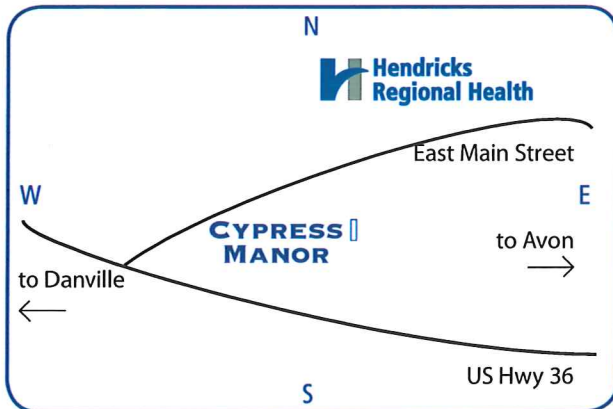
Fees for residency are based on individual income. Qualified individuals may receive Medicaid assistance for housing. All in-house services are included in the residency fees.

HOW TO APPLY

Application for residency at Cypress Manor can be made at our offices or through Township Trustees within Hendricks County. All applications must be approved by the Hendricks County Board of Commissioners at their regularly scheduled meetings. However, if an individual is in need of emergency housing, Township Trustees may make such appointment pending final approval by the Board of Commissioners.

However, the residence maintains much of its original timeless architectural beauty, and the citizens of Hendricks County continue to demonstrate their concern for the needy today as they did nearly 150 years ago.

STAFFING

Cypress Manor is staffed 24 hours a day by caring individuals experienced in meeting the physical, social and emotional needs of our residents.

TRANSITIONAL HOUSING

Transitional housing is available on a week-by-week or day-by-day basis. This area is located on the second floor with access separate from the rest of the building. Space is available for families with children or singles needing short-term housing of thirty days or less.

Four rooms with shared bath are available.

All transitional rooms share a kitchen and living space, and guests are responsible for their own meals. Smoking is not permitted within the building.

Referrals are accepted only through the offices of Township Trustees within Hendricks County.
