#### ORDINANCE NO. 2015-23

## ORDINANCE RESOLVING TO INCREASE PUBLIC SAFETY LOCAL OPTION INCOME TAX FOR THE HENDRICKS COUNTY CONSOLIDATED COMMUNICATIONS CENTER

WHEREAS, the elected officials within Hendricks County value public safety and have approved a total consolidation of public safety telecommunication centers within the county resulting in the Hendricks County Consolidated Communications Center ("HCCC"), a single Public Safety Answering Point ("PSAP") that is part of the statewide 911 system; and

WHEREAS, Hendricks County Communication Center consolidated in 2006 through interlocal agreement with 24 participating jurisdictions, each of which is a signatory to the interlocal agreement; and

WHEREAS, the interlocal agreement provides that the Center would be funded through E911 fees and other contributions of the participating jurisdictions until such time as a new method of funding the Center were approved legislatively; and

WHEREAS, the Indiana General Assembly has adopted and the Governor has signed House Enrolled Act 1475 (P.L. 157-2015) ("HEA 1475"); and

WHEREAS, Section 2 of HEA 1475 adds IC 6-3.5-1.1-25(n) to the Indiana Code, permitting a county council to approve an increase to the County Adjusted Gross Income Tax ("CAGIT") rate and permitting a county council to dedicate 100% of that increase to funding a PSAP; and

WHEREAS, the Governing Board of HCCC did, at its June 24<sup>th</sup> meeting, adopt a resolution recommending that the Hendricks County Council ("Council") adopt an increase to the CAGIT to be dedicated to funding HCCC pursuant to HEA 1475; and

WHEREAS, the Council has determined, in consultation with its financial advisors, that an increase of one tenth of a percent (.10%) would provide adequate funding for HCCC; and

WHEREAS, on August 13, 2015, the Council held a public hearing during which time members of the public were given an opportunity to be heard regarding the proposed CAGIT increase; and

WHEREAS, the Council desires to increase the CAGIT as recommended by the HCCC Governing Board and to dedicate 100% of the increase to funding HCCC.

#### NOW, THEREFORE, BE IT RESOLVED BY THE HENDRICKS COUNTY COUNCIL AS FOLLOWS:

1. The Hendricks County Council hereby increases the county adjusted gross income tax rate imposed upon the resident county taxpayers of the county from one and fifteen hundredths percent (1.15%) to one and twenty-five hundredths percent (1.25%).

- 2. The increase shall take effect as of October 1, 2015, pursuant to IC 6-3.5-1.1-1.5(b).
- 3. The Hendricks County Council hereby declares and resolves that 100% of the increase in CAGIT from the rate of one and fifteen hundredths percent (1.15%) in effect on July 1, 2015, to one and twenty-five hundredths percent (1.25%) effective October 1, 2015, shall be dedicated to funding the Hendricks County Consolidated Communications Center, a Public Safety Answering Point, as provided in IC 6-3.5-1.1-25(n).
- 4. The Hendricks County Auditor is directed to take all steps necessary to implement the resolutions as provided in this Ordinance, including, but not limited to, making a record of the vote taken on this Ordinance and, not more than ten (10) days after the vote, sending a certified copy of said vote record to the commissioner of the Indiana Department of Revenue, the director of the Indiana State Budget Agency and the commissioner of the Indiana Department of Local Government Finance using the Indiana Gateway for Government Units pathway.
- 5. This Ordinance is effective as of the date of its adoption.

As you are aware, the Hendricks County 911 Communications Center has operated successfully for several years. That is operationally, but not financially. An opportunity to properly fund the Center is now available, and we encourage your positive action to adopt a Public Safety Local Option Income Tax (LOIT).

For several Indiana General Assembly sessions in the past, many interested parties have requested legislation to permit adequate funding of the Center. This has involved members of the Hendricks County Commissioners, Township Trustees in the county, local police and fire administration and concerned citizens.

In the 2015 General Assembly session, the members passed, and the Governor signed, House Bill 1475, which authorizes the County Council to adopt a LOIT to provide funding for the Center. Adopting the LOIT would more equitably spread the cost of operating the Center among all residents of the County. This would enable the Center to continue to provide life and property saving services throughout the County, while also helping stabilize the local budgets of police and fire agencies.

We would urge you to adopt a Hendricks County Public Safety LOIT within the time frame specified by the law, so it can take effect as early as possible.
