**ZA 457/18:** JEFFREY J. LASKOWSKI; a zoning amendment change from RB/Single Family Residential District to AGR/Agriculture Residential District, 31.28 acres, Union Township, S32-T17N-R1W, located on the west side of State Road 39, south of Wyatt Way. (Comer Law Office)

**ZA 458/18: DUANE R. & PATRICIA J. LANE**; a zoning amendment change from MI/Major Industrial District to LI/Light Industrial District, 10 acres, Center Township, S11-T15N-R1W, located on south side of East County Road 75 South, between South County Road 150 East and South County Road 200 East. When the Public Hearing portion for each case is opened, please give your name and address at the podium and speak for no more than 3 minutes, or up to 10 minutes if you are representing a group. Discourteous, disorderly or contemptuous conduct shall be regarded as a breach of courtesy. Comments made by remonstrators shall be directed to the Commission and not to the applicant or any other person.
- 4. Every person appearing before the Commission shall abide by the directions of the President.
- 5. The Petitioner will have the opportunity to respond to remarks made by a remonstrator and answer additional questions from the Commission.
- 6. Once all testimony is taken, the public portion of the hearing is closed, and no further testimony will be taken.
- 7. The Commission may ask questions at any time of the Remonstrators or the Petitioner.
