HENDRICKS COUNTY COUNCIL DECEMBER 4, 2018

The regular meeting of the Hendricks County Council was called to order by President Eric Wathen on Wednesday December 4, 2018 with the following in attendance: Caleb Brown, Larry Hesson, Jay Puckett, Mike Rogers, Eric Wathen, Brad Whicker, David Wyeth, Financial Administrator Tami Mitchell, and Auditor Nancy Marsh. President Eric Wathen led the Pledge of Allegiance.

IN THE MATTER OF THE AGENDA

It was moved by Caleb Brown and seconded by David Wyeth to adopt the agenda as amended. Motion carried 7-0.

IN THE MATTER OF NOVEMBER 7, 2018 MINUTES

It was moved by Jay Puckett and seconded by Caleb Brown that the minutes of the November 7, 2018 meeting be approved as presented. Motion carried 6-0-1 (MR).

IN THE MATTER OF PLANNING AND BUILDING

Plan Director Tim Dombrosky asked that a revised job description be approved for the renamed position of Building and Floodplain Manager. Mr. Dombrosky stated that he submitted a revised job description to Human Resources that better defined the responsibilities and Human Resources deemed it a Professional and Technical 2. Mr. Dombrosky asked for the pay band go from OSS1 to PAT2 and the starting salary for 2019 be \$27.72 per hour with the expectation that there will be a review and possible increase to the midrange of \$30.81 per hour. It was moved by Caleb Brown and seconded by Brad Whicker to approve the Building and Floodplain Manager Pay Band at PAT2. Motion carried 7-0. It was moved by Caleb Brown and seconded by David Wyeth to approve the request that the 2019 hourly wage be approved at \$27.72 per hour with the expectation that there will be a review and possible increase to the mid-range of \$30.81 per hour. Motion carried 7-0.

IN THE MATTER OF THE CLASSIFICATION AND COMPENSATION STUDY

Council President stated that the Council and Commissioners were not satisfied with the Oliver System and had received proposals from First Person Advisors and Gallagher Benefit Services. Discussion was held on the pros and cons of each proposal. Mr. Whicker stated both were good but had very different presentations. Discussion was held on the size of the firms and their ability to meet our specific needs and the flexibility necessary for the county application. Commissioner Phyllis Palmer stated agreed that both had different positives and negatives and felt they both would provide a quality product and if it contained a cancellation clause, the Commissioners would support the Council's decision. It was moved by Larry Hesson and seconded by Caleb Brown that the Commissioners enter into an agreement, containing a cancellation clause, with First Person Advisors. Motion carried 5-2 (JP/BW).

IN THE MATTER OF THE AMENDED 2018 SALARY ORDINANCE

It was moved by Brad Whicker and seconded by Jay Puckett to approve the Amended 2018 Salary Ordinance 2018-26 which would authorize employee benefits to be included in the elected officials' salary. Motion carried 7-0.

IN THE MATTER OF THE 2019 SALARY ORDINANCE 2018-27

It was moved by Larry Hesson and seconded by Brad Whicker to approve the 2019 Salary Ordinance 2018-27 as presented. Motion carried 7-0.

IN THE MATTER OF RESOLUTION 2018- 28 AUTHORIZING THE AUDITOR TO MAKE CORRECTIONS

It was moved by Brad Whicker and seconded by Caleb Brown to authorize the Auditor, in coordination with the Financial Administrator, to make financial appropriation corrections and adjustments for One Hundred Dollars (\$100.00) or less to correct administrative errors by the Department Heads, Elected Officials, County Council and the Auditor. Motion carried 7-0.

IN THE MATTER OF THE EMERGENCY ADDITIONAL APPROPRIATIONS

It was moved by Larry Hesson and seconded by Jay Puckett to approve emergency additional appropriations number 1 through 9 as presented. Motion carried 7-0.
