Hendricks County Surveyor David Gaston informed the Board that the application check for Laurelton 1A had been stopped by the company and they owed the County \$750.00 for the application fee and \$56.00 for the returned check fee. Therefore, he recommended this project be Continued until they pay the fees. Discussion follwed. Mr. Stu Huckleberry of Lennar Homes stated he had the replacement checks to pay the fees. Discussion followed. Member Stan Ryland

moved to accept the checks and let Laurelton section 1B move foreward. Vice President Whetstone seconded the motion. The motion was unanimously passed.

Mr. Gaston stated based on the previous motion he recommended the Hendricks County Drainage Board grant Final Approval of *S-12-18 (Laurelton Section 1B)* subject to the conditions of the Hendricks County Surveyor's letter, all the requirements and conditions of the Hendricks County Stormwater Management Handbook and a \$100.00 per lot assessment payable to the Lingerman-Hardin Regulated Drain (497). Vice President Whetstone moved to follow the Surveyor's recommendation. Member Stan Ryland seconded the motion. The motion was unanimously passed.

Hendricks County Surveyor David Gaston recommended the Hendricks County Drainage Board grant Preliminary and Final Approval of *MRP 106/19 (Jessica & Matthew Quigley)* subject to the conditions of the Hendricks County Surveyor's letter and all the requirements and conditions of the Hendricks County Stormwater Management Handbook. Vice President Whetstone moved to follow the Surveyor's recommendation. Member Jack Maloney seconded the motion. The motion was unanimously passed.

RE: HENDRICKS COUNTY SURVEYOR DAVID GASTON:

Roseboom Regulated Drain (415)

Mr. Gaston informed the Board that Mrs. Jean Hughes had requested the Roseboom Regulated Drain assessment on her parcels be reduced. Discussion followed. Member Stan Ryland moved to Deny the request. Member Bob Gentry seconded the motion. The motion was unanimously passed.

Ross Regulated Drain (441)

Mr. Gaston stated, per the Board's request, that he had notified Boone County Surveyor Kenny Hedge that the Ross Regulated Drain study was complete and provided him a copy. Mr. Gaston informed the Board that he would be setting up a meeting with Mr. Hedge and Joe Miller of Banning engineering to go over the study and make recommendations to the Board.

2020 Budgets

Mr. Gaston presented the Board with the 2020 Budgets and stated the County Council had requested that the budgets remain the same as the 2019 Budgets. Discussion followed. Members Jack Maloney and Bob Gentry stated that they believed all the drainage inspectors deserved a raise above the County's approved raise percentage. Discussion followed. Vice President Whetstone moved to approve the 2020 Budgets with the exception that all drainage inspector line items receive a \$1000.00 increase and this was to be above the County's approved raise percentage. Member Bob Gentry seconded the motion. The motion was unanimously passed.

Farm Drains Informational Meeting

Mr. Gaston reminded the Board that the Farm Drain Informational meetings would be on June 12th, 2019 starting at 6:00 pm in meeting rooms four and five of the Government Center.

Crosswind Estates Regulated Drain

Mr. Gaston stated that the beavers were becoming a significant problem at Crosswind Estates. Inspector Dirk Leonard was going out once a week to break up the dams. Mr. Gaston ask the Board to allow his office to file a removal of obstruction against the parcel owners who were harboring the beavers. Discussion followed. Vice President Whetstone moved to approve the Surveyor's request and charge the parcel owners for the Removal of Obstruction. Member Bob Gentry seconded the motion. The motion was unanimously approved.

RE: IN THE MATTER OF WISHES TO BE HEARD:

Bryan Eller 6029 East County Road 121 North, Avon, Indiana 46123

Mr. Gaston informed the Board the Mr. Bryan Eller wished to build a barn in the fluvial erosion area of White Lick Creek and he had denied the request for that reason. Discussion followed. President Palmer recognized Mr. Eller. Mr. Eller through his narrative stated he had looked at several parcels before buying and had discussed them with the Planning and Building Department before deciding to buy this parcel. He said he was told by the Planning and Building Department that he could build a barn on this parcel. Discussion followed. Hendricks County Planning and Building Director Tim Dombrosky stated he believed his office could have told Mr. Eller he could build on this parcel due to the fact that it was designated as a buildable lot and outside the flood plain area. He said fluvial erosion was a new concept and not everyone understands what all is involved. Discussion followed. Member Jack Maloney moved to allow Mr. Eller to build his barn at his own risk and as far away from the creek as possible following all County ordinances and procedures. Vice President Whetstone seconded the motion. The motion was passed on a 4-1 vote with Member Bob Gentry voting against the motion.

<u>RE: INTRODUCTION OF OTHER BUSINESS OR ADDITIONAL DISCUSSION BY</u> BOARD MEMBERS:

Martin Dugan Regulated Drain

Member Jack Maloney stated the farm ground around the Martin Dugan Regulated Drain was in preventative planting and it would be optimal to repair/replace the tile at this time. Discussion followed.

Kate Lee Regulated Drain

Mr. Maloney stated the Kate Lee Regulated Drain had been damaged and 100 feet of it needed to be repaired or replaced. Discussion followed. Vice President Whetstone moved to have the 100 feet of tile replaced. Member Bob Gentry seconded the motion. The motion was passed on a 4-0-1 vote with member Jack Maloney abstaining.

Seeing nothing further before the Board, President Palmer moved to adjourn the meeting. Vice President Whetstone seconded the motion. The motion was passed unanimously.
