Application Deadline: Date by which a plan commission application must be filed to be heard the next month. The Surveyor's Office uses the same deadline for Drainage Board applications.

Site Visit: The date staff will visit the project site. A notice of the hearing may be posted on the site.

Public Notice Deadline: Date by which the legally required public notice must be submitted. This is done by staff.

TAC Review: The date the Technical Advisory Committee reviews the application with the applicant. Unless other arrangements are made, the applicant is required to attend.

Preliminary Consultation: An informal meeting between staff and a prospective applicant to discuss the feasibility of a project.

Written Notice Deadline: Date by which the applicant must have mailed notice to nearby property owners.

Plan Commission Hearing: Date of the Plan Commission hearing.

A&P Committee Hearing: Date of the Administrative and Plat Committee hearing. ****Nov meeting time will be determined at a later date****
