1. *If you wish to speak regarding a specific case, please sign the correct sign-in sheet.*
2. *For each case, Petitioner will have 15 minutes to make a presentation.*
3. *When the Public Hearing portion for each case is opened, please give your name and address at the podium and speak for no more than 3 minutes, or up to 10 minutes if you are representing a group. Discourteous, disorderly or contemptuous conduct shall be regarded as a breach of courtesy. Comments made by remonstrators shall be directed to the Commission and not to the applicant or any other person.*
4. *Every person appearing before the Commission shall abide by the directions of the President.*
5. *The Petitioner will have the opportunity to respond to remarks made by a remonstrator and answer additional questions from the Commission.*
6. *Once all testimony is taken, the public portion of the hearing is closed, and no further testimony will be taken.*
7. *The Commission may ask questions at any time of the Remonstrators or the Petitioner.*
