An individual who changes the use of their property and fails to file a certified statement with the auditor of the county notifying them of the change within 60 days, is liable for the amount of the deduction allowed for the property plus a civil penalty of 10% of the additional taxes due.

Proof of Indiana Residency shall consist of one of the following documents: valid Indiana Driver's License or State ID, Indiana Voter Registration Card or Indiana State Income Tax Return with address of property claiming Homestead Deduction.

<sup>\*\*</sup>Can be applied as Excise Tax Credit on either the motor vehicle excise tax (IC 6-6-5-5) or the aircraft license excise tax (IC6-6-6.5) calculated at \$2 for cars and \$7 for aircrafts for each \$100 of unused deduction.

<sup>\*\*\*</sup> Code 3= 100% wartime service connected disability or a partially disabled deduction combined with a totally disabled deduction when the individual reaches the age of 62.
