# Health First Indiana - Hendricks County

## **Background**



Hendricks County opted in to "Health First Indiana" public health initiative. The goal of HFI was to identify strengths and weaknesses and develop strategies to ensure that all Hoosiers have access to core public health services that help prevent disease and promote positive health outcomes. With these funds, the Hendricks County Health Department (HCHD) expanded its internal and external capacity to improve health outcomes through increased programming, hiring new positions, and funding projects of community organizations.

## Community Awards

HCHD developed a collaborative approach to distribute funding to community organizations. These projects will increase efforts and capacity to address key core performance indicators. These indicators include:

- Maternal and Child Health
- Access to and Linkage to Clinical Care
- School Health Education

## Community Award Process

HCHD developed an application for community partners to apply for program funding. This application is available through our website. A team at the Health Department would receive and review the applications received and make recommendations on how to proceed. If more information was needed, applicants were invited to a review session that included health department members and an advisory team. The advisory team consisted of longstanding community partners from various agencies that provided a variety of perspectives and expertise. The review sessions were a chance to ask applicants were notified and program data will be used for HFI reporting.


#### 2024 Naloxone Rescue Kit — Grant Activity Highlights

The Hendricks County Health Department distributed 167 Nasal Naloxone Rescue Kits through a grant from the Indiana State Department of Health received in 2023. Trained around 50 Hendricks County laypersons or agency professionals in 2024, including laypersons, local community organizations and businesses, and housing facilities.


The Health Department utilizes a second grant through Overdose Lifeline to provide 24/7 accessible naloxone through Naloxboxes in Brownsburg, Avon, and Plainfield. Through this program, we distributed approximately 264 doses of Naloxone in 2024.








#### **HCHP Local Coalition Updates**

The Health Partnership restructured in 2022 and has continued to make great progress through its new format. The Partnership meets once a month to discuss progress on our community action plan, as well as invite speakers to share about the work they're doing. In 2024, we concluded our 2023-2024 behavioral health action plan, and met many of the goals we set. Funding was provided to community partners to address behavioral health needs utilizing an ARPA grant acquired in 2023. Monthly meetings averaged around 45 monthly attendees, but there are over 80 regularly participating partners. A new interactive version of the Community Resource Guide was created and went through Beta testing by partners, and will launch in 2025.

- Launched Tobacco Coalition

## Preparedness Year in Review 2024



- Taught 13 Stop the Bleed classes training 229 individuals and distributing basic Stop the Bleed kits to each one
- Facilitated 7 CPR courses training 72 individuals
- Attended all District 5 Healthcare Coalition monthly meetings and the spring and fall tabletop exercise
- Attended all District 5 Public Health preparedness Coordinator meetings
- Attended Emergency Preparedness meetings at Hendricks Regional Hospital
- Formed Hendricks County Public Safety Radio committee consisting of Health Department, Emergency Management, Communications Center, and Information Technology to oversee the AM radio messaging
- Continued work on Health Department Continuity of Operations planning
- Attended Hendricks County School Safety Committee meetings and took part in reunification exercises with Avon School Corporation
- Began planning meetings for Tabletop exercise that took place in November
- With Local Emergency Planning Committee (LEPC) and Emergency Management, began discussing plans for full scale exercise slated for Fall 2025
- Conducted 4 quarterly Emergency Support Function 8 committee meetings
- Attended meetings and training leading up to April 8<sup>th</sup> total eclipse
- Facilitated meetings and training that led to a completed Community Emergency Response Team (CERT) training on September 7, 14<sup>th</sup> and 21<sup>st</sup> with 14 people completing the training
- Continued recruitment efforts for Medical Reserve Corps (MRC). 15 new people were added to the roster for 2024.
- Facilitated 2 meetings with the Hendricks County Healthcare Related Facility Taskforce consisting of long-term care, assisted living, home health, dialysis, and hospice to discuss planning and preparation for the eclipse
- Attended all Hendricks County LEPC meetings
- Attended and presented a session at the National MRC summit in Chicago
- As chair of the Indiana Environmental Health Association (IEHA) Terrorism and All Hazards Preparedness Committee, facilitated a tour of the Indiana State Emergency Operations Center. Additionally brought 3 different FEMA training classes to Hendricks County training a total of 84 people
- Facilitated Safe Worship training and offered 2 sessions during the year, training 73 people.
- Participated in Red Cross Shelter training to cross train MRC members in shelter operations with 15 MRC members in attendance
- Participated in 2 Active Shooter exercises (Putnam County and Pittsboro)
- Attended and facilitated presentations at the IEHA Fall Conference
- Worked with local fire and EMS chiefs for possible MOU in future to utilize Health Department equipment if needed
- Worked with EMA to develop mass casualty plan for the county and conducted meeting to bring private ambulance service providers into the planning process
- Participated in Public Safety Day events in Brownsburg and Plainfield, National Night Out events in Brownsburg, Danville and Plainfield and Back your Badge marathon in Plainfield
- Began work with National Environmental Health Association on piloting an exercise and work force enumeration project
- Held a Personal Preparedness workshop for the public that brought the National Weather Service and the Board of Animal Health also. Discussed the need for preparedness before winter and distributed items including a hand crank weather radio/flashlight
